GRANT OF PERMANENT

EASEMENT AND RIGHT-OF-WAY-FOR A PUBLIC STREET

KNOW ALL MEN BY THESE PRESENTS, that COMMERCIAL BANK TRUSTEE ("Grantor"), of Lake County, Indiana, for valuable consideration, does hereby grant unto the CITY OF CROWN POINT, INDIANA ("Grantee"), a permanent right-of-way to layout, construct, use, maintain, inspect, and repair a public street, together with all necessary equipment or fixtures used in connection with said public street, over and across the following described real estate located in Lake County, Indiana, to-wit:
