CORPORATE DEED

THIS INDENTURE WITNESSETH that STRACK AND VAN TIL SCHERERVILLE SUPER MARKET, INC., an Indiana corporation (hereinafter the "Grantor"), QUIT CLAIMS AND RELEASES to STRACK AND VAN TIL SUPER MARKET, INC., an Indiana corporation (hereinafter the "Grantee"), in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the following described real estate situated in Lake County in the State of Indiana, to-wit:

An undivided one-half (1/2) interest as tenants in common in: That part of the East Half of Section 32, Township 35 North, Range 9 west of the Second Principal Meridian, described as beginning at the Northeast corner of the Southeast Quarter of said Section 32; thence South 0 degrees 3 minutes 35 seconds East along the East line of said Section 32 a distance of 335.0 feet; thence South 89 degrees 56 minutes 25 seconds West a distance of 622.66 feet; thence North 0 degrees 03 minutes 15 seconds West a distance of 778.0 feet; thence North 89 degrees 56 minutes 25 seconds East a distance of 622.66 feet to a point on the East line of said Section 32; thence South 0 degrees 03 minutes 35 seconds East along said East line a distance of 443.0 feet to the point of beginning, all in the Town of St. John, Lake County, Indiana.


