of LAKE County in the State of INDIANA

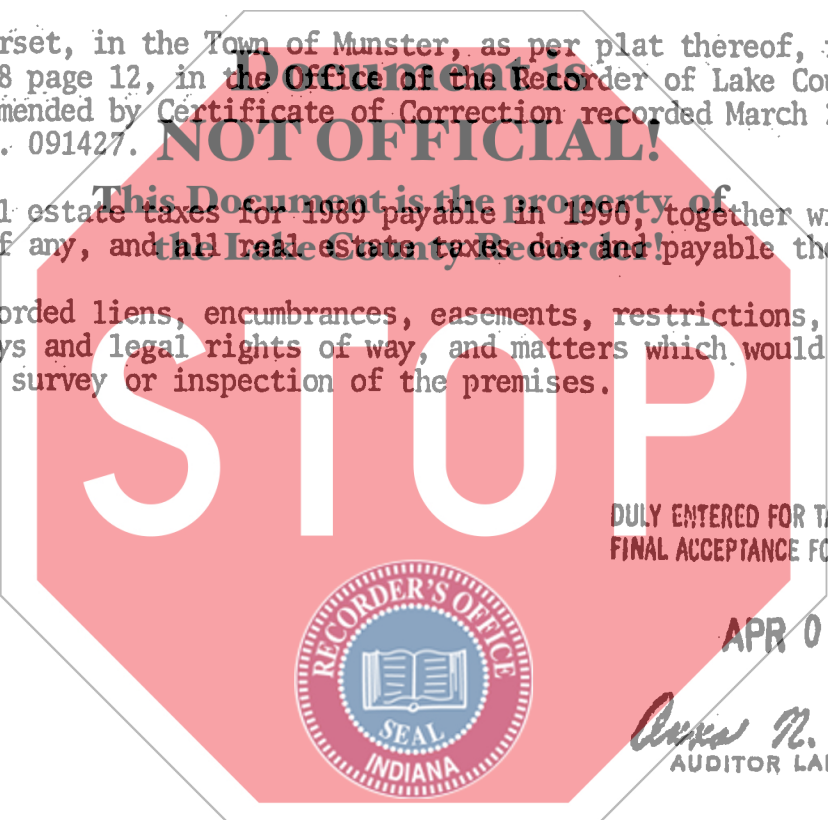
Convey and warrant to THOMAS W. BAUGHMAN
