I, ROBERT G. ANDERSON S/S #364-22-2403, residing at 8745 Jane Way #6, Munster, Indiana 46321, being of full age and of sound disposing mind and memory, do hereby make, publish and declare this to be my Last Will and Testament, and hereby revoking all wills and codivils by me heretofore made.

ITEM 1: I direct that all of my just and enforceable debts be paid out of my trust estate as soon as practicable after the time of my decease.

All estate, inheritance, succession and other death taxes which shall become payable by reason of my death, shall be paid out of my trust estate as an administration expense.

ITEM 2: I give, devise and bequeath my entire trust estate, whether real property or personal property, of every kind, name and description, whatsoever and wheresoever situated, which I now own or hereafter acquire, to the Successor Trustees of the Robert G. Anderson Trust, to be held, managed and disposed of in accordance with the provisions of said Trust which was established by a Declaration of Trust dated *April 6, 1990*, between Robert G. Anderson grantor and Rosalind Gassel; Robert J. Anderson; Donna M. Giffoni; Patrice L. Valand, and David C. Anderson as joint trustees, and which is now in existence.

ITEM 3: I nominate and appoint trustee PATRICE L. VALAND, to be the Executrix of this, my Last Will and Testament, hereby authorizing and empowering my said Executrix to compound, compromise, and settle and adjust all claims and demands which may be presented against my Trust Estate or which may be due to my Trust Estate upon my death. All such settlements are to be made from my Trust Estate.

ITEM 4: I nominate and appoint the successor trustees to sell at private or public sale, lease or exchange, at such prices and upon such terms of credit or otherwise as they may deem best, the whole or any part of my real or personal property, and to execute, acknowledge and deliver deeds or other proper instruments of conveyments thereof to the purchaser or purchasers, all without license or leave of court.

ITEM 5: I request that no bond be required of my Successor Trustees for their services.
