the grantees acknowledge that the same may be used for gardens, shrubs, fencing, landscaping, and other purposes that do not interfere with the use of said easement for such aerial cable purposes. Grantee further acknowledges that this grant of permanent easement is subject to the following conditions:

- 1. That any damages to personal property, including but not limited to fences, improvements, driveways, landscaping, growing crops, and timber lying within the easement shall be paid in full when damaged and grantee acknowledges that such damages are not included in the sums paid to secure the easement.
- of said easement with roads, driveways, field tile, and other utilities, including water, electricity, gas and sewer lines, both storm and sanitary, subject, however, to the following: (a) Grantor and his agents and contractors shall at all times exercise reasonable care to prevent damage to Grantee's cable or other facilities, and (b) shall give Grantee not less that 2 working days notice prior to engaging in any construction activities within 15 feet of the easement, strip, so as to permit Grantee to locate its cable or other facilities, and Grantor shall permit Grantee to have a representative present during any such activities, and (c) has avoided excavating or digging directly where Grantee's representative has identified the cable or other facilities to be located, or, if that is not feasible, followed Grantee's representative's reasonable suggestions (such as hand excavation) to avoid damage to the cable or other facilities.
