AFFIDAVIT OF SURVIVORSHIP

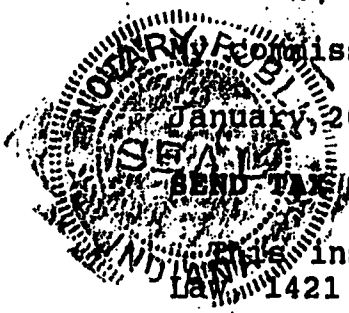
