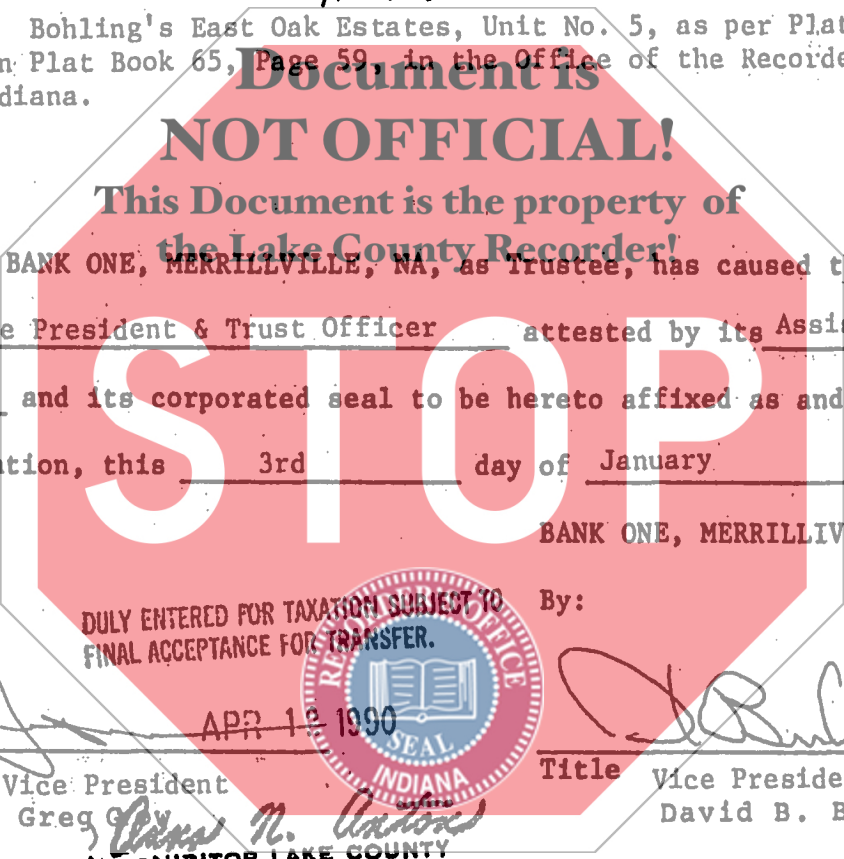


TRUSTEE'S DEED
