ORDINANCE NO. 90- 05

AN ORDINANCE VACATING FRONTAGE ROAD
IN THE TOWN OF MERRILLVILLE, LAKE COUNTY, INDIANA

WHEREAS, Whiteco Industries, Inc., has filed a petition to vacate a frontage road in Merrillville, Indiana; and

WHEREAS, a public hearing has been held as required by I.C. 36-7-3-12; and

WHEREAS, the Town Council of the Town of Merrillville has determined after the public hearing that the frontage road requested to be vacated should be vacated.

NOW THEREFORE, be it resolved by the Town of Merrillville:

1. That the following described frontage road should be vacated by the Town of Merrillville, to wit:

40 foot frontage road located south of real estate legally described as:

Lot 7 and Lot 8 of the Amended Plat of Subdivision of Prime Center Property as recorded in the Office of the Recorder of Lake County, Indiana on February 2, 1990 in Book 67, page 64.

2. A copy of this Ordinance shall be recorded with the Recorder of Lake County and shall be delivered to the Auditor of Lake County for posting to the Auditor's records.

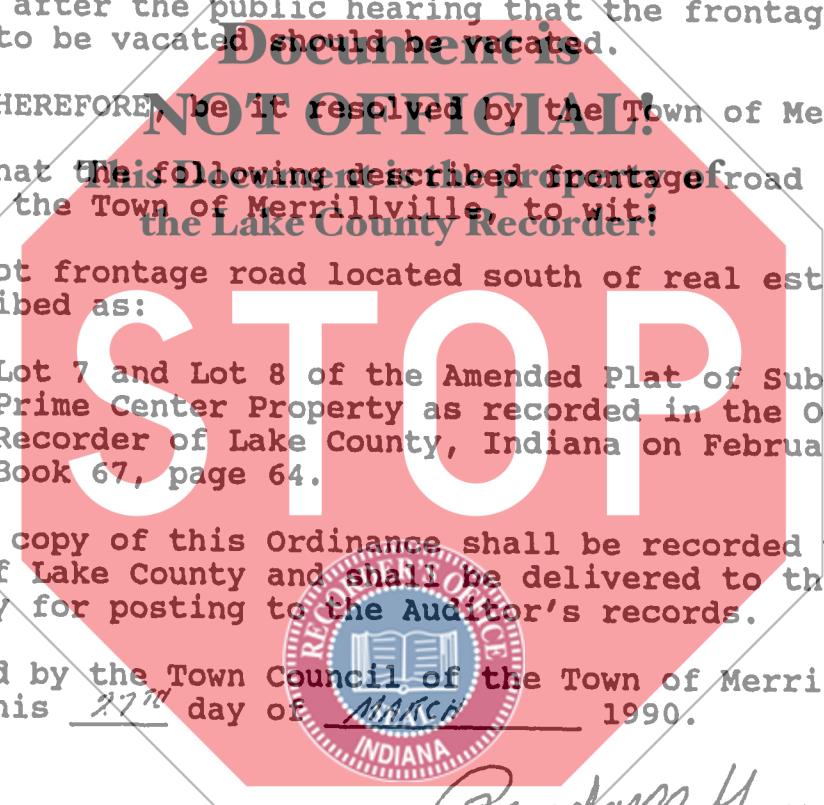
