ASSIGNMENT OF MORTGAGE

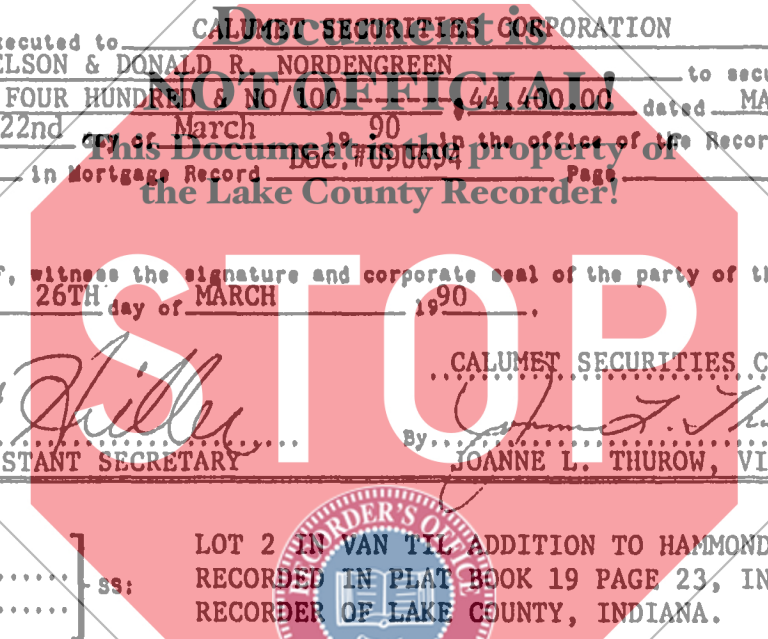
