AFFIDAVIT OF HEIRSHIP

Robert R. Fisher, being first duly sworn on oath says as follows:

1.) He resides at 3012 S. Canal Street, Chicago, Illinois 60616 and is the husband of IRENE A. FISHER, who died on April 20, 1989 at the age of 77 years. At the time of her death the said IRENE A. FISHER resided at 3012 S. Canal Street, Chicago, Illinois 60616. She left a Will, dated August 8, 1984, which has been filed with the Clerk of the Circuit Court of Cook County, Illinois but which has not been admitted to probate. A certified copy of said Will accompanies this Affidavit. Under the terms of the Will the decedent, IRENE A. FISHER, gave, devised, and bequeathed her entire estate to the affiant, ROBERT R. FISHER, who does not intend to have the Will admitted to probate.

2.) At the time of her death the decedent, IRENE A. FISHER was the owner of an undivided 1/2 interest in the following described real estate in Lake County, Indiana:

Lots 28 and 29, Block 10, Plat "B", The Shades, in Cedar Lake, as shown in Plat Book 11, Page 30, in Lake County, Indiana.

The value of said 1/2 interest did not exceed the sum of \$5,000.00.

3.) The decedent, IRENE A. FISHER, was married only once, and then to the affiant, ROBERT R. FISHER. She was never divorced from affiant, ROBERT R. FISHER, and remained married to him and lived with him up to the time of her death. No children were ever adopted by the said IRENE A. FISHER. Only one child was ever born to her, namely ANTOINETTE M. FISHER, now living, of legal age, and a single person who has never been married. The said ANTOINETTE M. FISHER was born to the decedent, IRENE A. FISHER, as a result of decedent's marriage to the affiant, ROBERT R. FISHER.

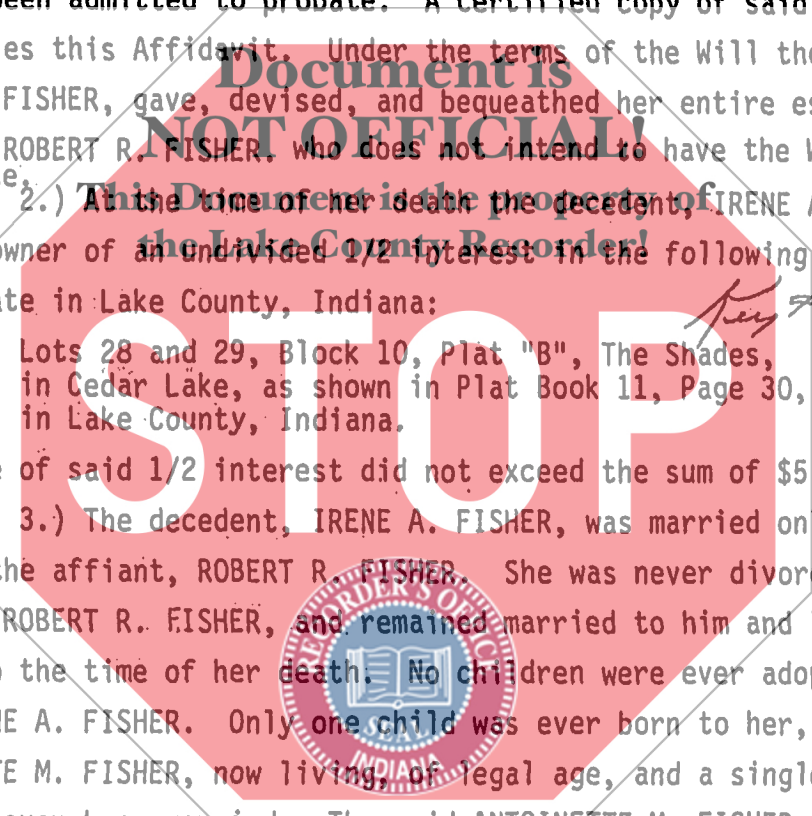
4.) Accordingly, at the time of her death, the decedent, IRENE A. FISHER left her surviving as her only heirs at law:
