4. That the Executor and surety be and hereby are discharged and released and that the estate be and hereby is closed.

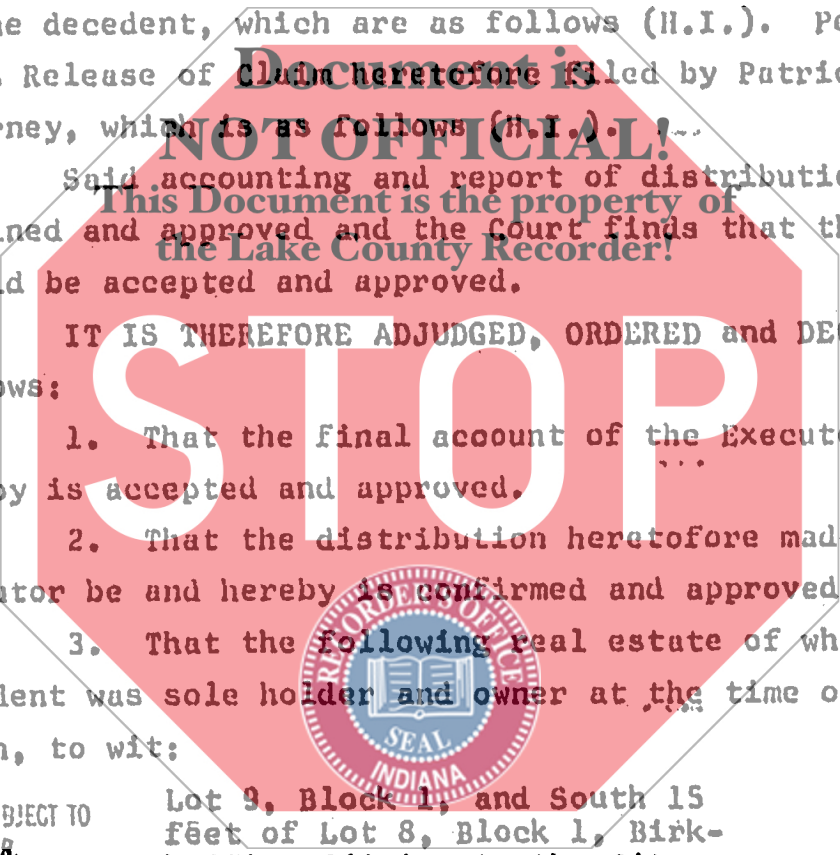

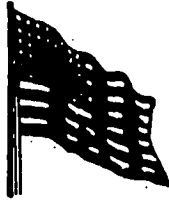
