




ORDERED, ADJUDGED AND DECREED by the Court that the Plaintiffs are entitled to an order quieting title to the property described as follows:

That parcel conveyed to or acquired by The Pittsburgh, Cincinnati, Chicago & St. Louis Railway Company, by deed dated June 25, 1902 and recorded July 2, 1902 in book 101, pages 93, 94, and 95 and subsequently conveyed to or acquired by the Consolidated Rail Corporation, situated in Sections 4 and 9, Township 35 North, Range 9 West of the Second Principal Meridian, originally designed as a "y" between the Pittsburgh, Cincinnati, Chicago & St. Louis Railway Company and the Elgin, Joliet & Eastern Railway Company, containing 1.95 acres, all in Lake County, Indiana,

and the Clerk of the Court is ordered to forward a copy of this order on to the Recorder for filing in the Quiet Title Judgment Book.
