in full force and effect until September 20, 1990, unless renewed by Continuation Certificate.

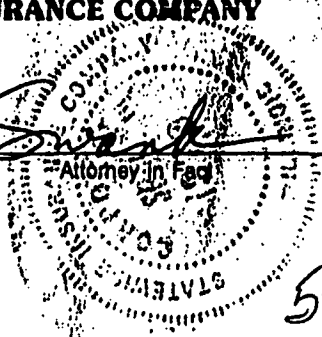
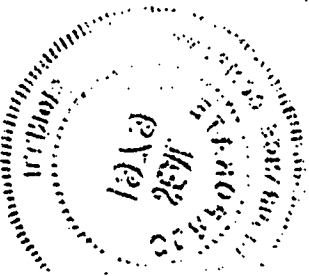
PROVIDED, HOWEVER, This bond may be cancelled by the Surety thirty (30) days after receipt by the Obligor of the Surety's

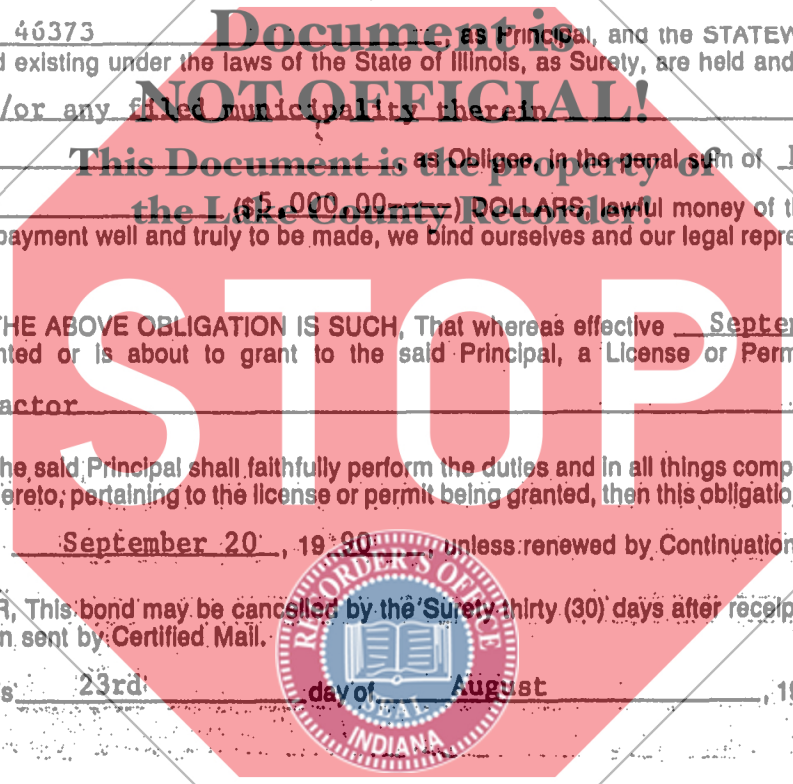

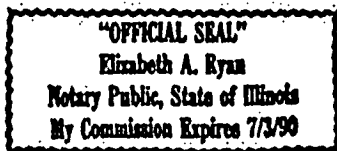

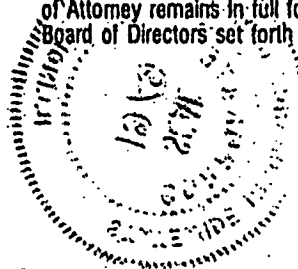
