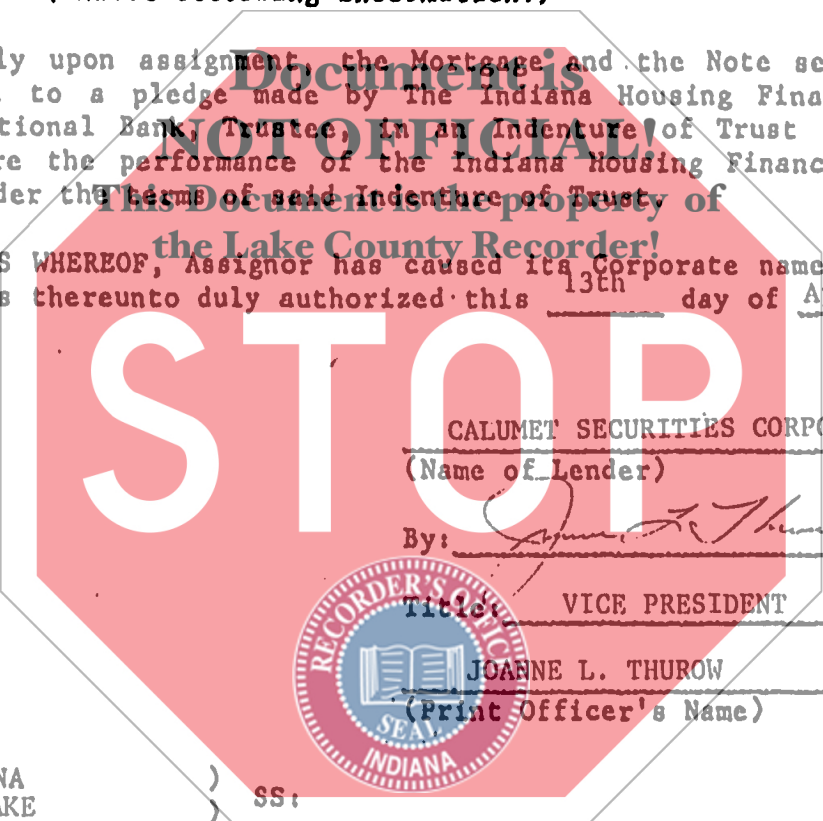
Form of Assignment of Mortgage

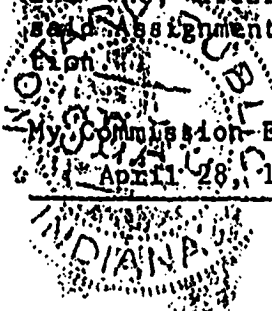
