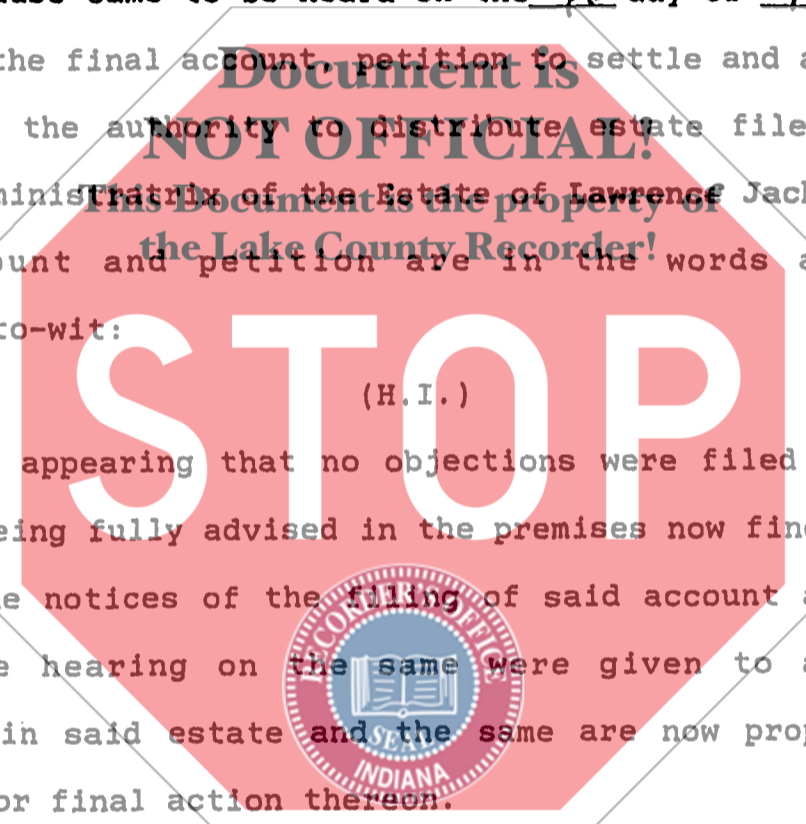

is hereby vested in solely in Carrie Rutland.

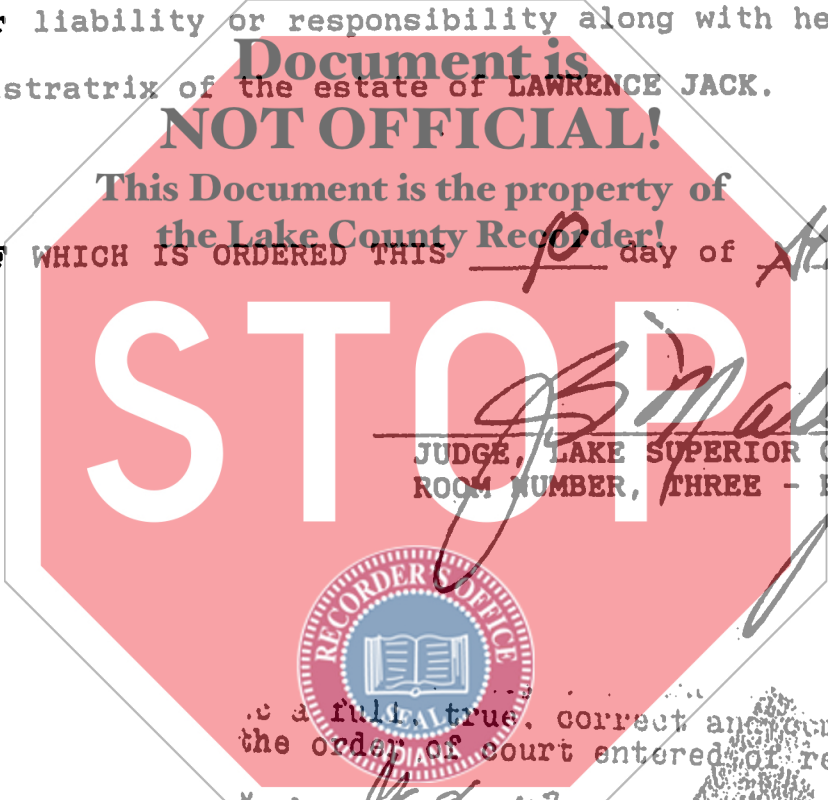
And that said administratrix is hereby directed to procure and record in the Office of the Recorder of Lake County, being the County in which said real estate is located, a certified copy of this Final Decree.
