 Indenture of Trust.

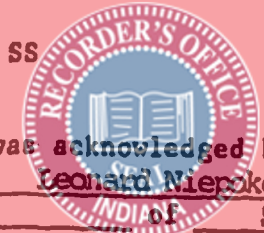
