# DEED OF PERSONAL REPRESENTATIVE

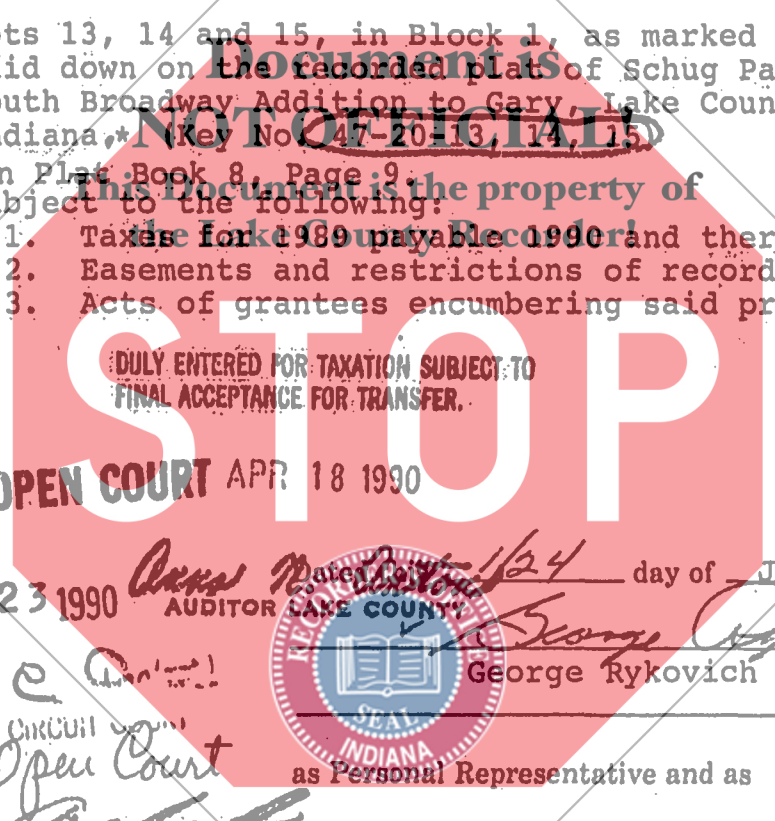
GEORGE RYKOVICH, as Personal Representative,
