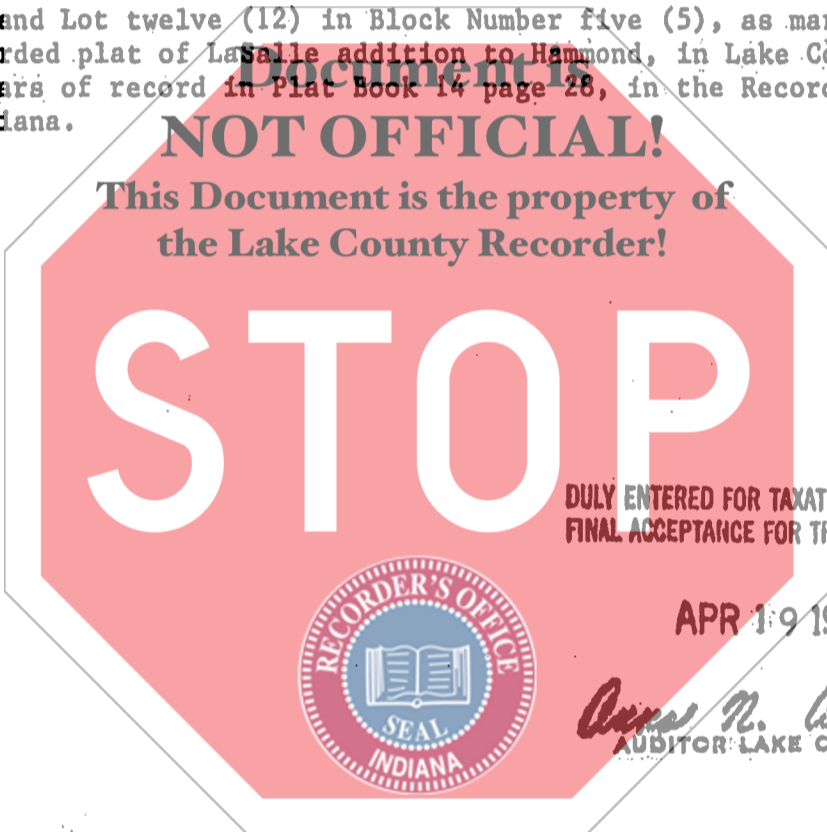
This indenture witnesseth that JOSEPH C. BIELAK and MARY I. BIELAK, Husband and Wife
