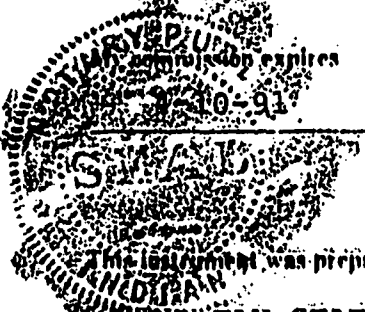

LEGAL DESCRIPTION

That part of Government Lot 4 in Section 26, Township 34 North, Range 9 West of the 2nd Principal Meridian, lying North of the North line of C. N. Straight's Addition to Cedar Lake, East of the East line of Binyon's 2nd Addition to Cedar Lake, West of the Westerly line of Binyon Road and South of the South line of the road which is 95 feet North of and parallel to the North line of Straight's Addition aforesaid, in Lake County, Indiana, EXCEPT THE FOLLOWING:

That part of Government Lot 4, Section 26, Township 34 North, Range 9 West of the 2nd P.M., in Lake County, Indiana, more particularly described as follows: Lying North of and adjacent to all of Lot 36 and the West half of Lot 35, Block 1, C. N. Straights Subdivision and South of the South line of the road which is 95 feet North of and parallel to the North line of C. N. Straights Subdivision, being the premises which lie between the West line of Lot 36 and the East line of the West half of Lot 35, as said lines are extended Northerly to the South line of the road.

That part of Government Lot 4 in Section 26, Township 34 North, Range 9 West of the 2nd Principal Meridian, in Lake County, Indiana, more particularly described as follows: Commencing at the Northeast corner of Lot 32, Block 1, C. N. Straight's Subdivision, in the Town of Cedar Lake, as shown in Plat Book 8, page 20; thence East along the North line of said C. N. Straight's Subdivision, 255 feet to a point on the North line of Lot 26, Block 1, C. N. Straight's Subdivision, 5 feet East of the Northwest corner of said Lot 26; thence North on a line 5 feet East of and parallel to the West line of said Lot 26 extended North, to the South line of the road which is 95 feet North of and parallel to the North line of said C. N. Straight's Subdivision; thence West 255 feet to the point of intersection of the South line of the road with the East line of Lot 32, C. N. Straight's Subdivision, extended North; thence South to the place of beginning.

That part of Government Lot 4 in Section 26, Township 34 North, Range 9 West of the 2nd P.M., in Lake County, Indiana, more particularly described as follows: Lying North of and adjacent to Lots 32 and 33, Block 1, C. N. Straight's Subdivision and South of the South line of the road which is 95 feet North of and parallel to the North line of said C. N. Straight's Subdivision, being the premises which lie between the East line of Lot 32 and the West line of Lot 33, as said lines are extended Northerly to the South line of the road.

That part of Government Lot 4, Section 26, Township 34 North, Range 9 West of the 2nd P.M., in Lake County, Indiana, more particularly described as follows: Lying North of and adjacent to all of Lot 34, and the East Half of Lot 35, Block 1, C. N. Straights Subdivision and South of the South line of the road which is 95 feet North of and parallel to the North line of C. N. Straights Subdivision, being the premises which lie between the East line of Lot 34 and the West line of the East Half of Lot 35, as said lines are extended Northerly to the South line of the road.

That part of Government Lot 4, in Section 26, Township 34 North, Range 9 West of the 2nd P.M., in Lake County, Indiana, more particularly described as follows: Lying North of and adjacent to Lots 18, 19 and 20, Block 1, C. N. Straight's Subdivision, and South of the South line of the road which is 95 feet North of and parallel to the North line of said C. N. Straight's Subdivision, being the premises which lie between the East line of Lot 18 and the West line of Lot 20, as said lines are extended Northerly to the South line of the Road.
