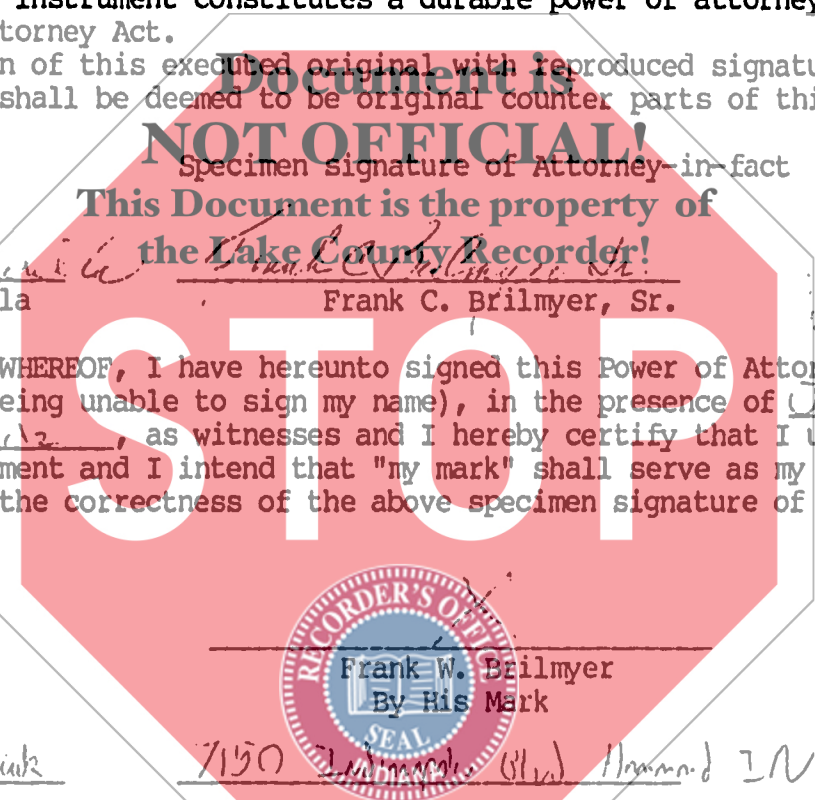

DURABLE POWER OF ATTORNEY

I, FRANK W. BRILMYER, of Lake County, Indiana, being of sound mind, do hereby make and appoint Frank C. Brilmyer, Sr., and Joanne M. Churilla, both of Lake County, Indiana, as my true and lawful attorneys-in-fact, for me and in my name to draw and to endorse checks upon all bank accounts standing in my name, individually or in a fiduciary capacity; to demand and receive all sums of money as are now or shall hereafter become due; to compromise the same; to sell, assign, mortgage, convey and transfer any interest I have in real estate or personal property wherever located, of which I am the owner or in which I have an interest now or hereafter and to execute and deliver all instruments necessary in furtherance thereof; to execute and file all tax returns and to pay such taxes; I grant to my said attorney, free access to any safe deposit box I may have in any financial institution and to sign any instruments, necessary to gain admission thereto; to employ and pay agents and/or attorneys to assist my attorney-in-fact; to arrange for and pay my medical, hospital and nursing expenses, including admission to hospitals and nursing homes; to consent or to reject medical treatment if I am unable to do so, and to make application for insurance and health benefits related thereto; to generally transact any and all business for me of any kind whatsoever necessary or proper to be done in all matters affecting my business, property or myself, reserving unto myself, however, the power to act on my own behalf and also to revoke the powers given by this instrument. This Power of Attorney shall not extend to the revocation or amendment of any Will or Trust executed or created by me now or hereafter. This Power of Attorney shall not be affected upon my subsequent disability or incapacity or lapse of time, it being my intention that this instrument constitutes a durable power of attorney under the Indiana Durable Power of Attorney Act.

Reproduction of this executed original with reproduced signatures and certificate of acknowledgement shall be deemed to be original counter parts of this Power of Attorney.
