INDEMNIFYING MORTGAGE

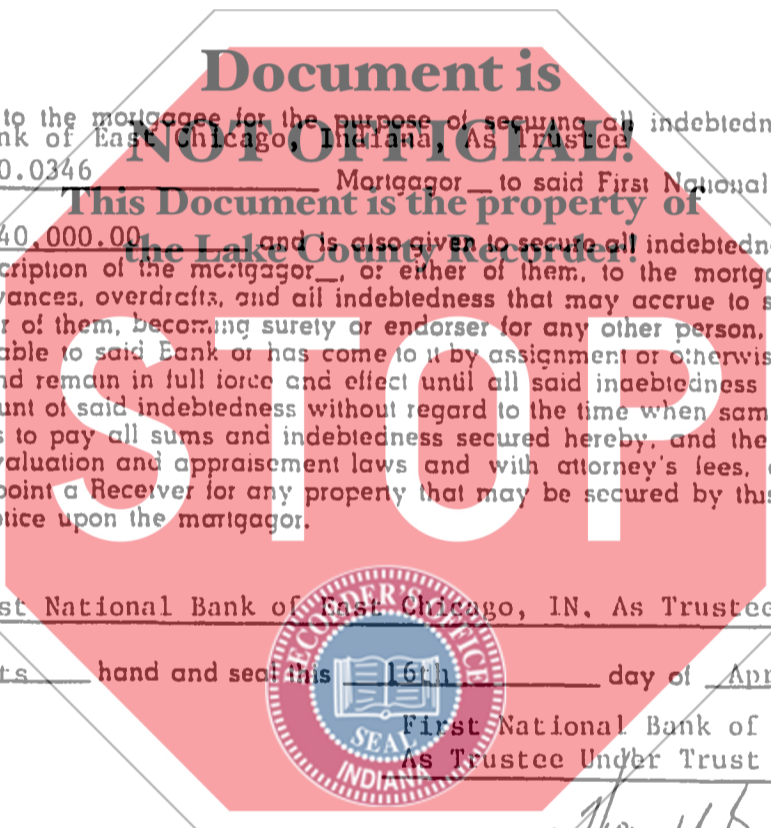
THIS INDENTURE WITNESSETH THAT First National Bank of East Chicago, Indiana, As Trustee
