ORDINANCE NO. 90-12

AN ORDINANCE VACATING ALLEY  
IN THE TOWN OF MERRILLVILLE, LAKE COUNTY, INDIANA

WHEREAS, Welsh Oil, Inc. has filed a petition to vacate an alley in Merrillville, Indiana; and

WHEREAS, a public hearing has been held as required by I.C. 36-7-3-12; and

2. A copy of this Ordinance shall be recorded with the Recorder of Lake County and shall be delivered to the Auditor of Lake County for posting to the Auditor's records.
