AMENDED
LAST WILL AND TESTAMENT OF

The second floor to TOMMY WILLIAMS and the third floor to KENNETH JEROME FORD. The remainder of all my properties real and personal to be divided equally between ELVERTICE WILLIAMS AND KENNETH JEROME FORD. And Five Hundred (\$500.00) Dollars to be given to LILLIAN SAMPSON at 2642 Waite St., Gary, Indiana 46404, Gary, Indiana. To Ione J. Carter (My Accountant, 1137 Bigger Street, Gary, Indiana 46404 I give and bequeath One Thousand (\$1,000.00) Dollars.

ARTICLE III

I nominate and appoint IONE J. CARTER (My Accountant) to be the executor of my estate and request that the bond be fixed at the lowest possible amount.

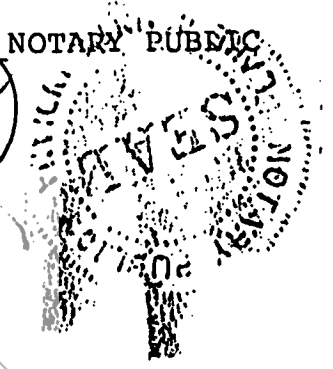
