to be made, we bind ourselves and our legal representatives, jointly and severally by these presents.

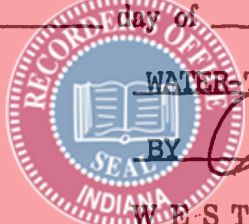
THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That whereas, the said Principal

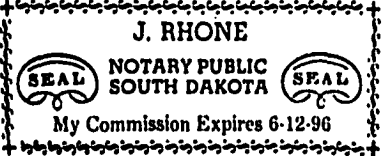
