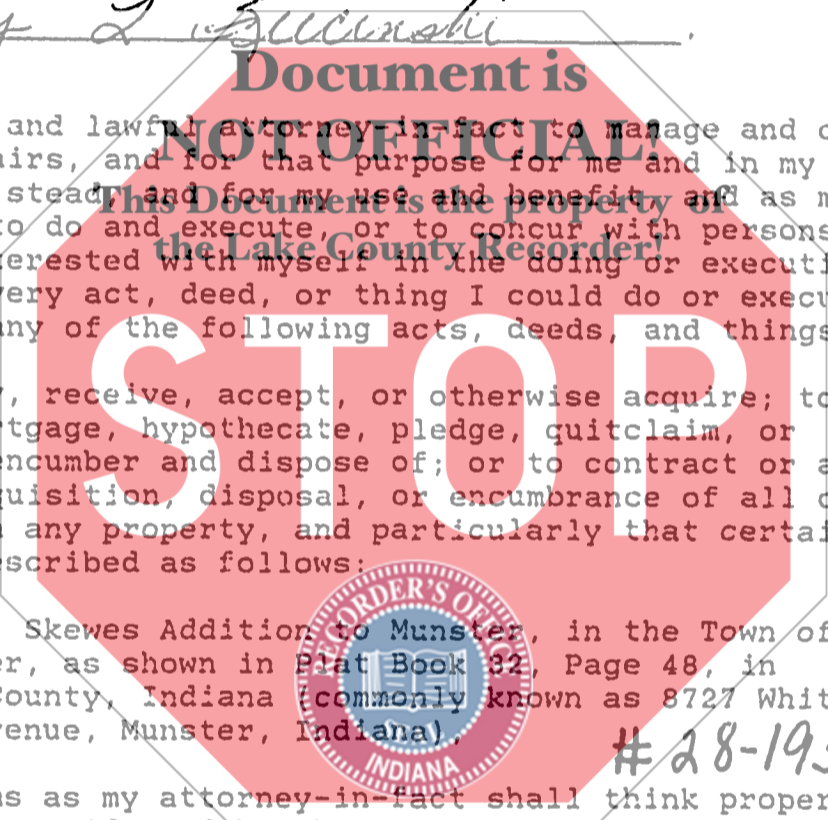
all on terms as my attorney-in-fact shall think proper as conclusively evidenced by the attorney-in-fact's action;

(2) To make, endorse, guarantee, accept, receive, sign, seal, execute, acknowledge, and deliver closing statements, deeds, assignments, bills of sale, agreements, certificates, hypothecations, checks, notes, mortgages, bonds, vouchers, receipts, releases, and other instruments in writing of whatever kind and nature, as may be necessary, convenient, or proper.

IN FURTHERANCE OF THESE POWERS, I give my attorney-in-fact full power and authority to do for me and in my name all those things which such attorney-in-fact deems expedient to and necessary to effectuate the intent of this instrument, as fully as I could do personally for myself, reserving unto myself, however, the power to act on my own behalf and also to revoke the powers given in this instrument.

Any act or thing lawfully done by my attorney-in-fact under this instrument shall be binding on me and on my heirs, assigns and legal representatives.

Persons to whom this instrument may be delivered may rely on its being in effect and unrevoked unless and until actual notice of my death or other revocation of this instrument shall have been received by any person acting in
