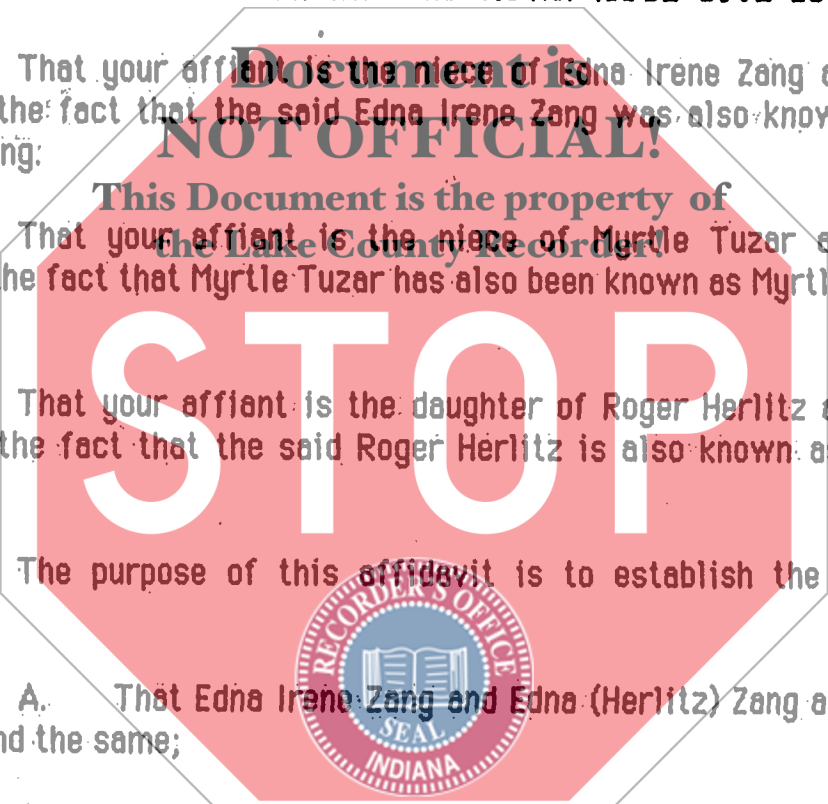
4. That your affiant is the daughter of Roger Herlitz and hereby attests to the fact that the said Roger Herlitz is also known as Roger R. Herlitz.

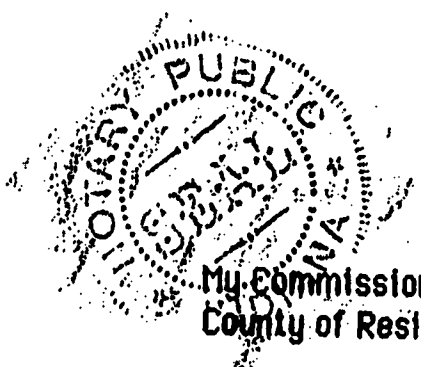
