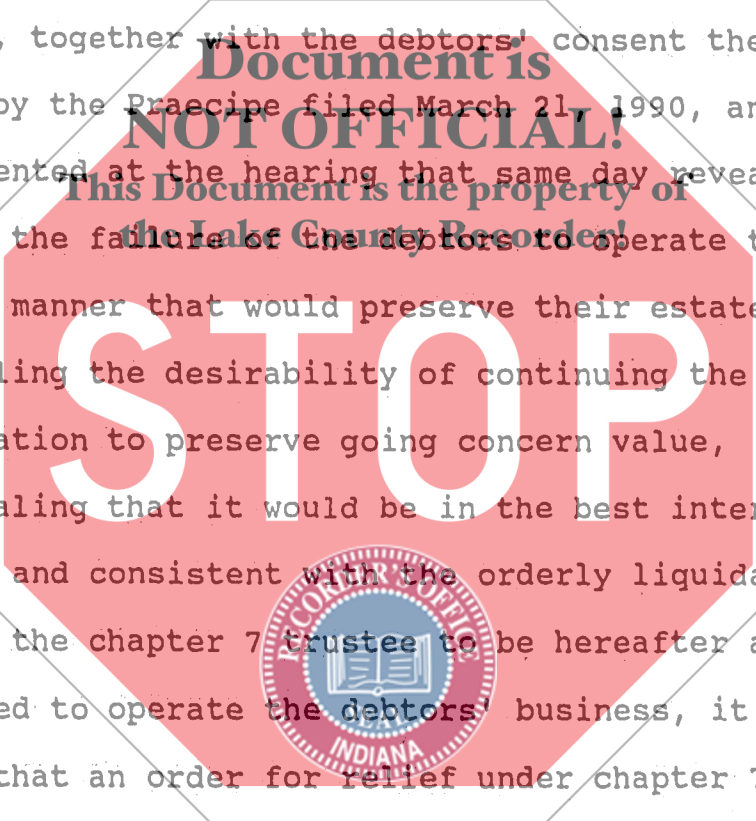

ORDER FOR RELIEF UNDER CHAPTER 7 AND ORDER AUTHORIZING TRUSTEE TO OPERATE BUSINESS OF DEBTOR

On consideration of the involuntary petition filed on March 2, 1990, together with the debtors' consent thereto, as reflected by the Praecipe filed March 21, 1990, and the evidence presented at the hearing that same day revealing (if relevant) the failure of the debtors to operate their business in a manner that would preserve their estate assets, revealing the desirability of continuing the business operation to preserve going concern value, and thus revealing that it would be in the best interest of the estate and consistent with the orderly liquidation of the estate if the chapter 7 trustee to be hereafter appointed were authorized to operate the debtors' business, it is

ORDERED that an order for relief under chapter 7 of the Bankruptcy Code is GRANTED and it is further

ORDERED that the chapter 7 trustee to be appointed by the U.S. Trustee upon entry of this order of relief is authorized to operate the business of the debtor, in accordance with 11 U.S.C. § 721, until April 23, 1990. It is further

ORDERED that, inasmuch as the order for relief has been consented to and is now entered, the Motion for Appointment of Interim Trustee is DENIED as moot. It is further

ORDERED that the praecipe filed by the debtors indicating an interest to convert to Chapter 11 does not serve as a motion to convert to Chapter 11 and no conversion will be ordered absent the motion required by the rules.
