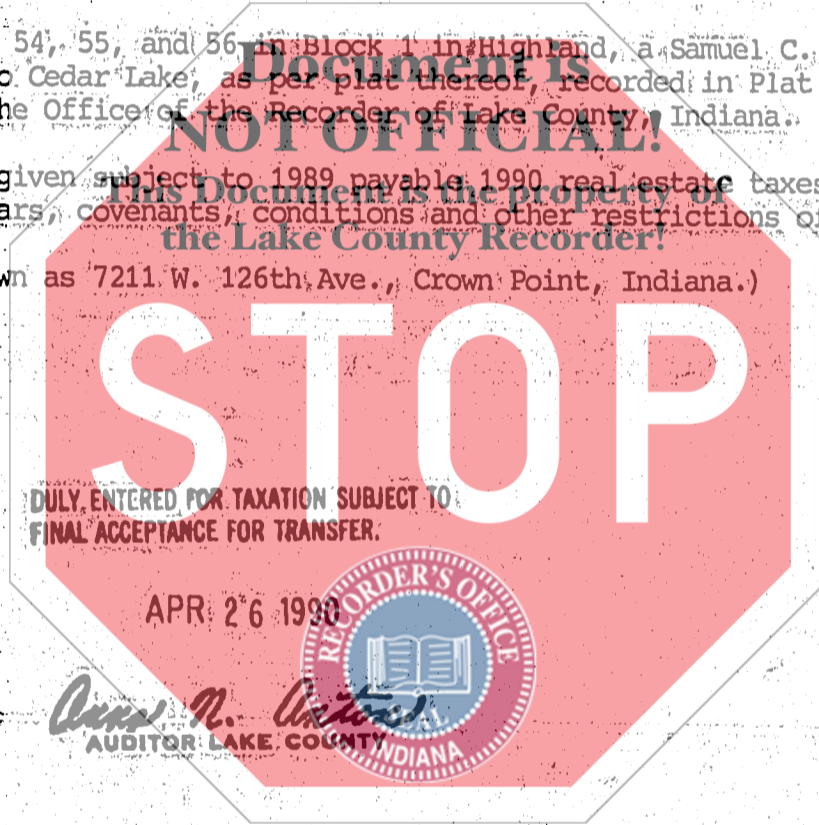
Convey and warrant to Laura Foreman and Brian P. Terry, as joint tenants with rights of survivorship and not as tenants in common.
