And it appearing that no objections were filed thereto and the Court being fully advised in the premises, now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
2. That Lena Plowman died testate, a resident of Lake County, Indiana, on the 5th day of May, 1989, and her Last Will and Testament was duly admitted to probate before this Court on the 17th day of May, 1989, and this Court appointed Mary Schultz and Louise Norwich as Co-Executrices of the decedent's Last Will and Testament, and said personal representatives were issued Letters Testamentary on the 17th day of May, 1989, and since that date they have continued to serve in such capacity.
3. That the matters and things stated in said account and petition are true and that said personal representatives have accounted for all of the assets in this estate coming into their hands.
4. That more than five (5) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her personal representatives were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:

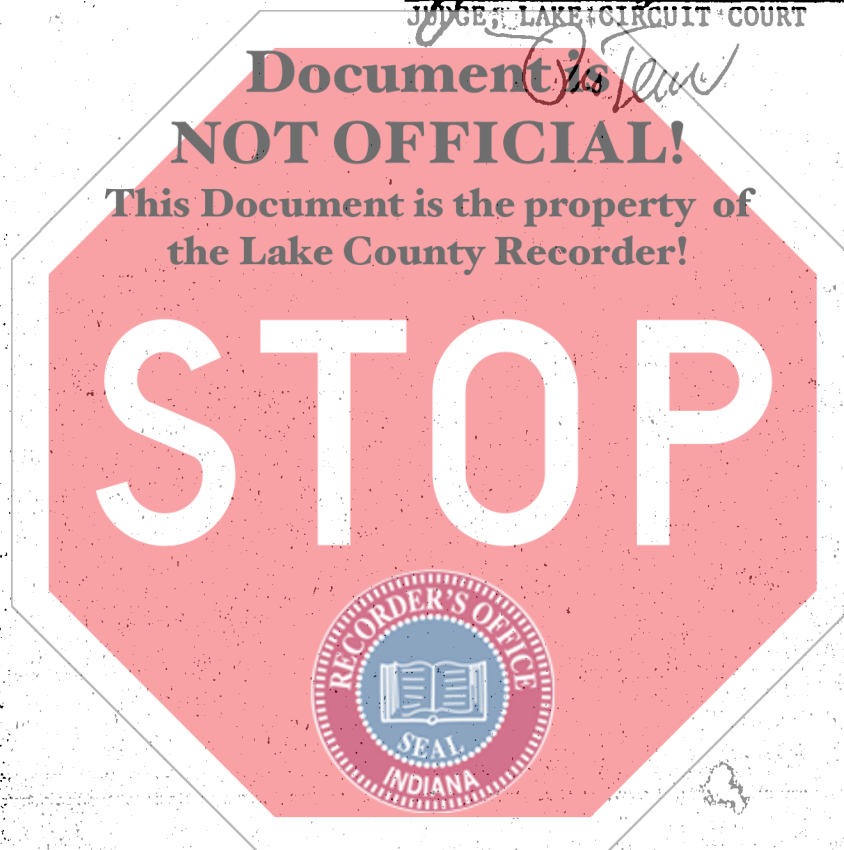

is hereby vested in Lena Kucan pursuant to the provisions of the decedent's Last Will and Testament.

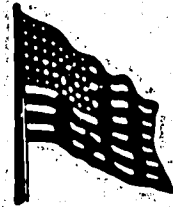

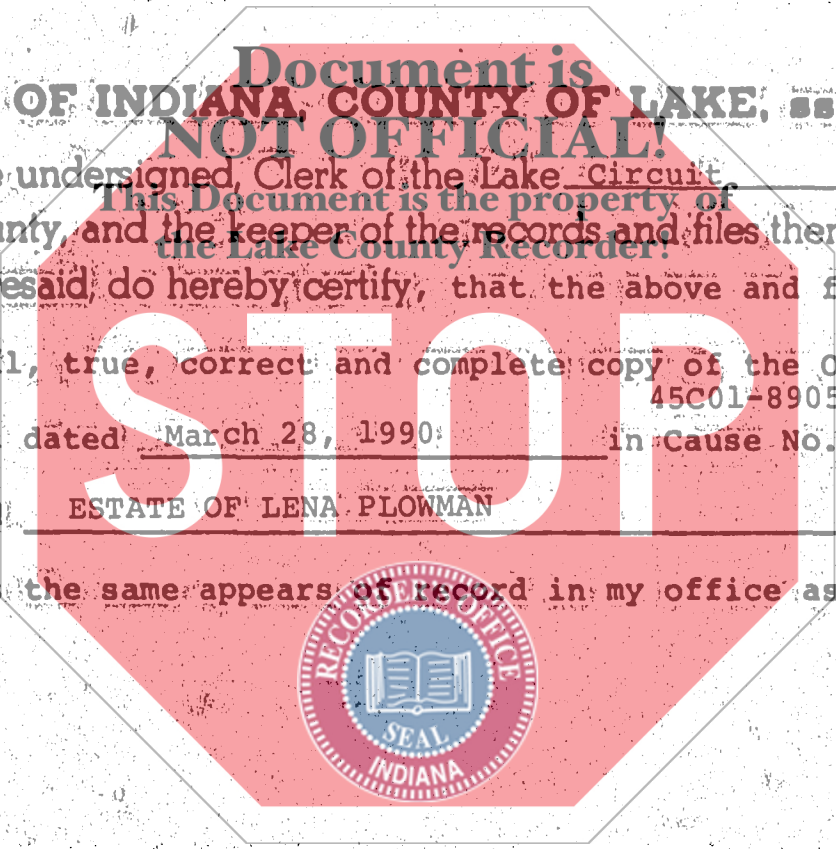
