# Last Will and Testament of

FOURTH: In the event my daughter, Joani Bragdon, predeceases me, then and in that event, I give, devise and bequeath all of the rest, residue and remainder of my property and estate, both real and personal, of any nature whatsoever and wherever situated, of which I may die seized and possessed, or to which I may be entitled at the

time of my death, to my brother, William Bragdon.

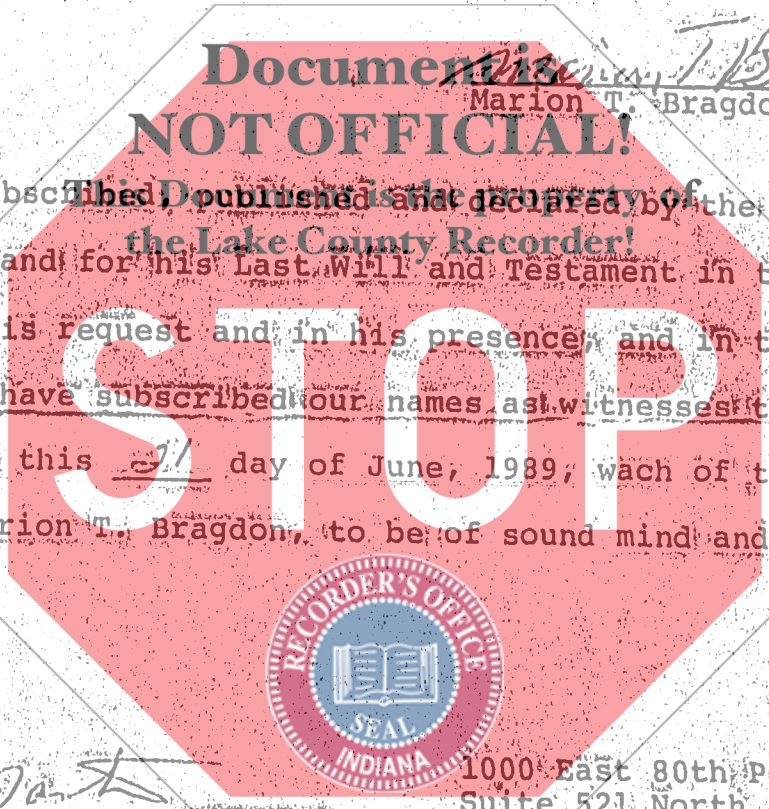
