## POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS:

its true and lawful attorney-in-fact, with full power and authority hereby conferred in its name, place and stead, to execute, seal, acknowledge and deliver ANY OR ALL BONDS, UNDERTAKINGS, RECOGNIZANCES OR OTHER WRITTEN OBLIGATIONS IN THE NATURE THEREOF ~~NOT TO EXCEED THE PENAL SUM OF TEN MILLION DOLLARS (\$10,000,000).~~
