AFFIDAVIT OF SURVIVORSHIP

Comes now Anne C. Leady, being first duly sworn upon her oath and states as follows:

That Anne C. Leady is the personal representative of the Estate of John L. Urbanek, Sr. and the daughter of John L. Urbanek, Sr., and has personal knowledge of the matters set forth herein.

That the Estate of John L. Urbanek, Sr., is the owner in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows:

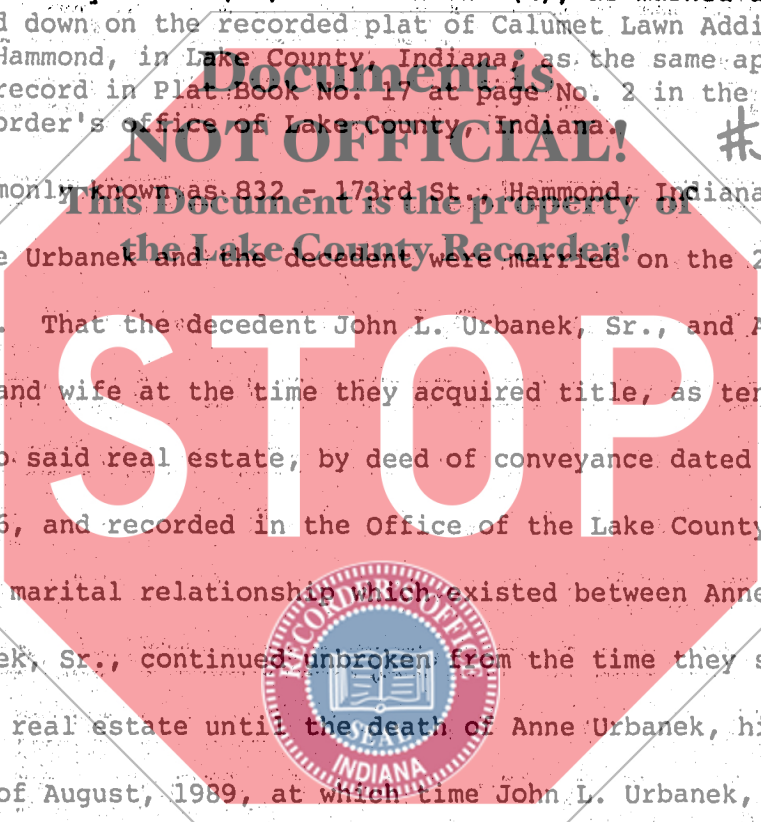
Commonly known as 832 - 173rd St., Hammond, Indiana.

That Anne Urbanek and the decedent were married on the 22nd day of October, 1945. That the decedent John L. Urbanek, Sr., and Anne Urbanek were husband and wife at the time they acquired title, as tenants by the entireties, to said real estate, by deed of conveyance dated the 12th day of March, 1946, and recorded in the Office of the Lake County Recorder.

That the marital relationship which existed between Anne Urbanek and John L. Urbanek, Sr., continued unbroken from the time they so acquired title to said real estate until the death of Anne Urbanek, his wife, on the 13th day of August, 1989, at which time John L. Urbanek, Sr., acquired title to the real estate as surviving tenant by the entireties.

That the gross value of the estate of the decedent, Anne Urbanek, as determined for the purpose of Federal Estate Taxes, was less than the value required for the filing and the decedent's estate was not subject to Federal Estate Tax.

That Anne Urbanek's estate was not subject to Indiana Inheritance Tax.
