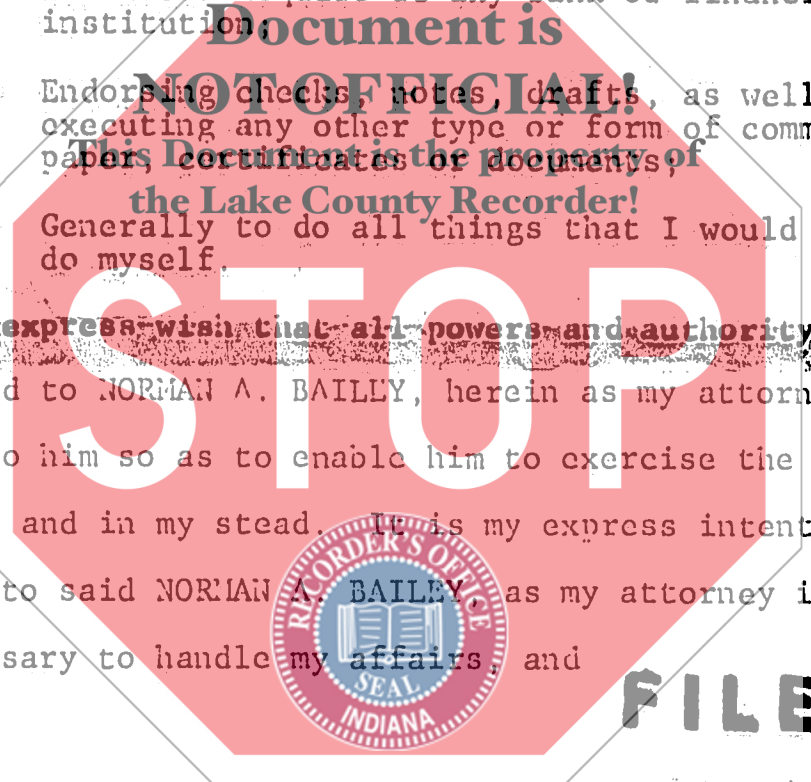
Power of Attorney
