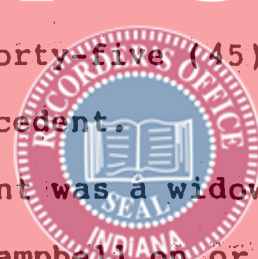
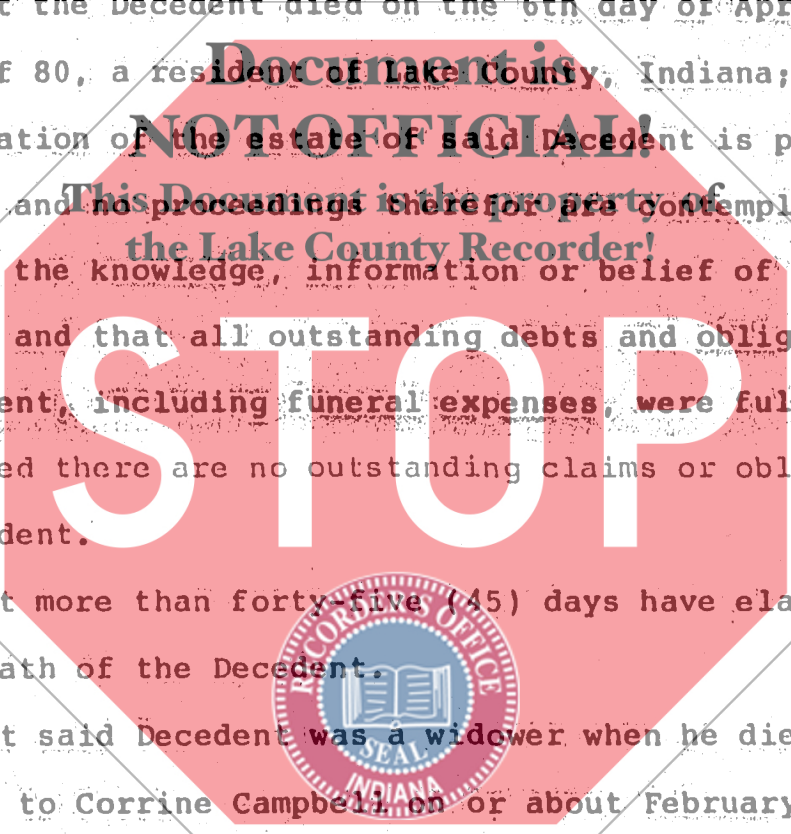
1. That the Decedent died on the 6th day of April, 1986,
