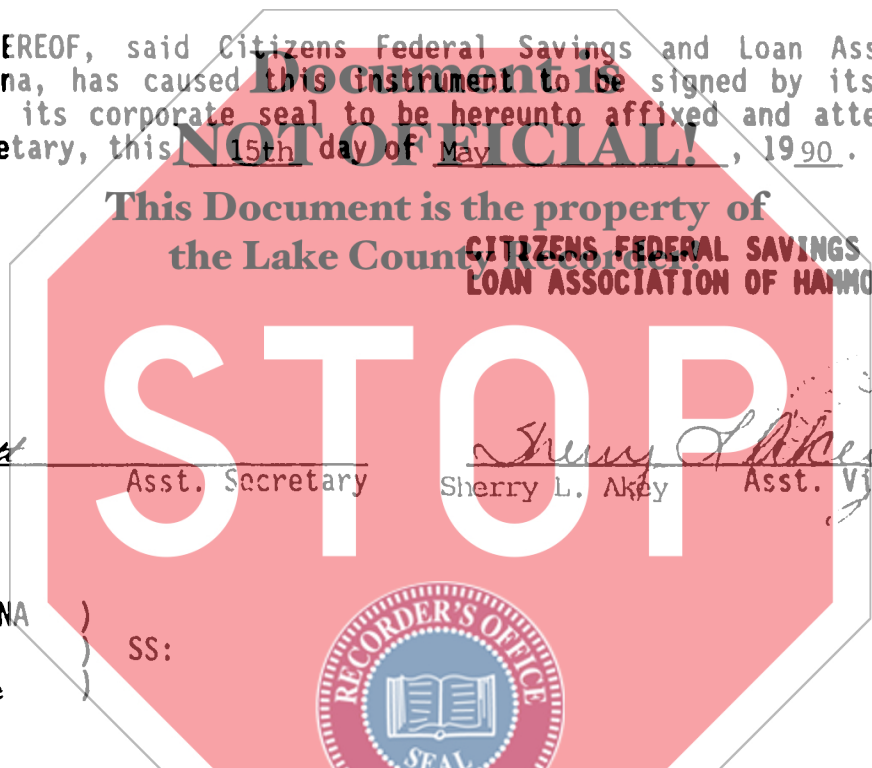
SATISFACTION OF MORTGAGE

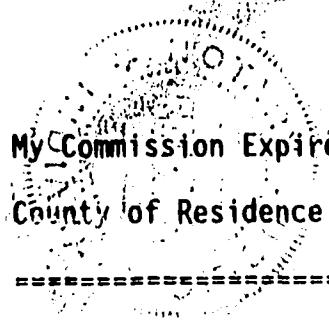
