SMALL ESTATES AFFIDAVIT

Myrtle M. Bohling, the undersigned Affiant herein, being duly sworn upon oath states as follows:

- 1. That Donald M. Bohling died testate on August 25, 1983 while domiciled at Rt.#2, Hebron, Porter County, Indiana and that the Will of decedent was not probated.
2. That no petition for the appointment of a personal representative of said decedent is pending or contemplated in any Court in this State and that more than forty-five (45) days have elapsed since the death of the decedent.
3. That the following named persons are the only heirs, legatees or devisees of the decedent: Myrtle M. Bohling, Surviving Spouse

5. Bohling to Donald M. Bohling, Robert E. Bohling and Donna S. Forsythe. Said Mortgage is in the amount of \$1,000.00, and is dated Feb. 28, 1972 and recorded as Document No. 138476 on Feb. 28, 1972.
6. That there are no creditors of the estate.
7. That by reason of the above-stated matters, the affiant requests that the above-enumerated personal property of the decedent be transferred to her in accordance with provisions of I.C. 29-1-8-1 and I.C. 29-1-8-2 as part of her surviving spouse's allowance as provided by IC 29-1-4-1.

WHEREFORE Affiant hereby requests that her interest in said mortgage be transferred to her as part of her statutory spouse's allowance and that in return therefore she will execute an appropriate Satisfaction of Mortgage for and on behalf of said decedent to the said Kenneth N. 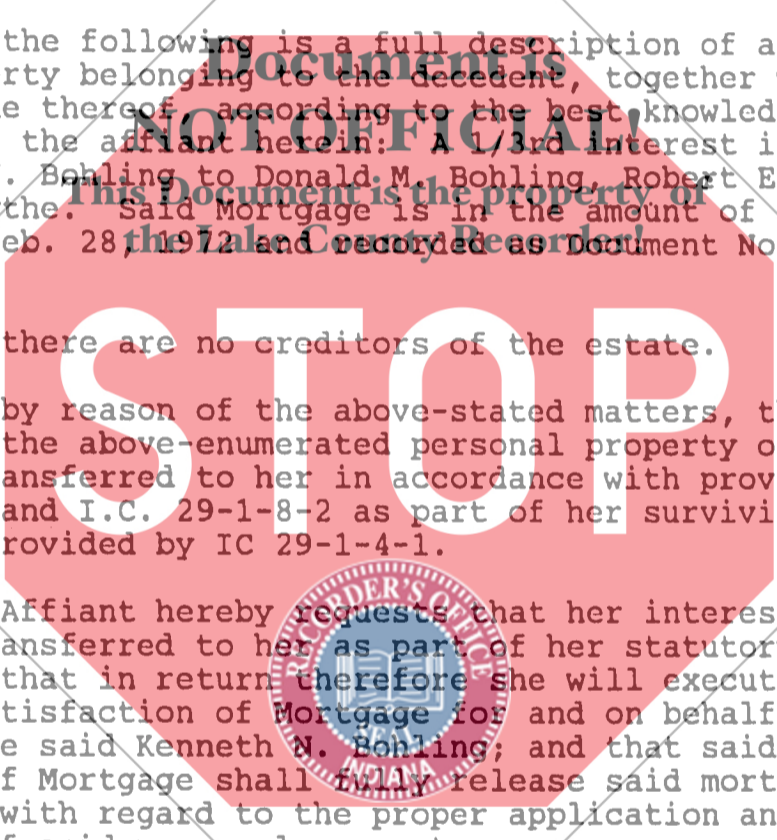
