- 1. The patient was admitted to the hospital on May 4, 19 90 and discharged from the hospital May 5, 19 90.

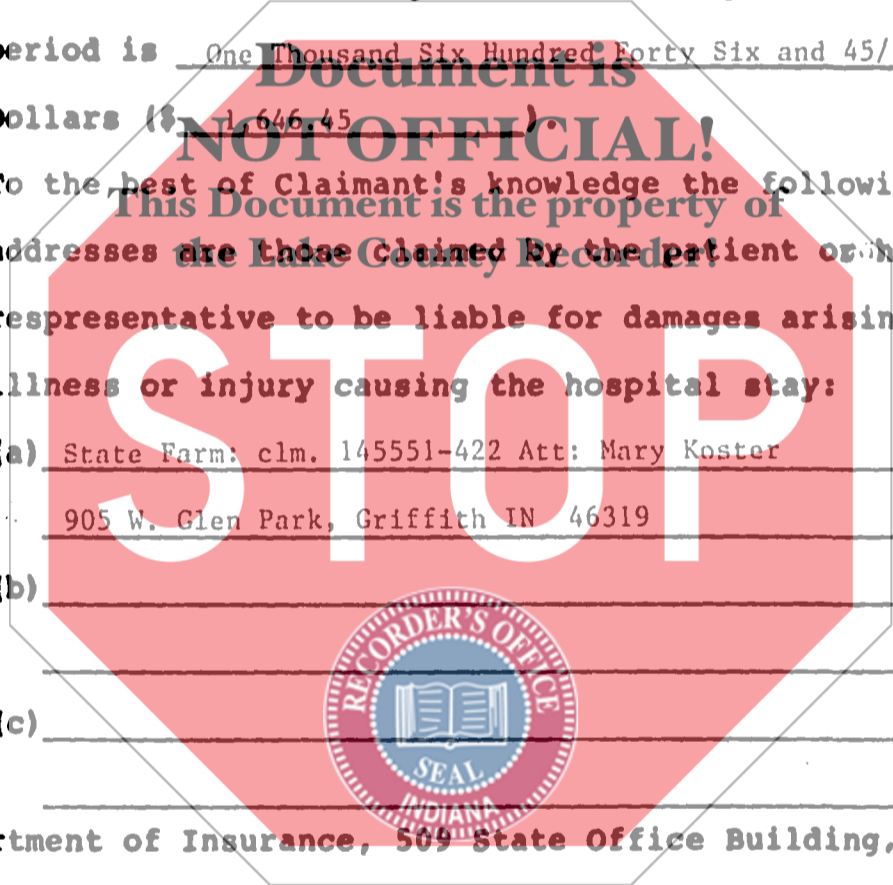
- 2. The amount due for hospital care during the above time period is One Thousand Six Hundred Forty Six and 45/100 Dollars (\$ 1,646.45).
