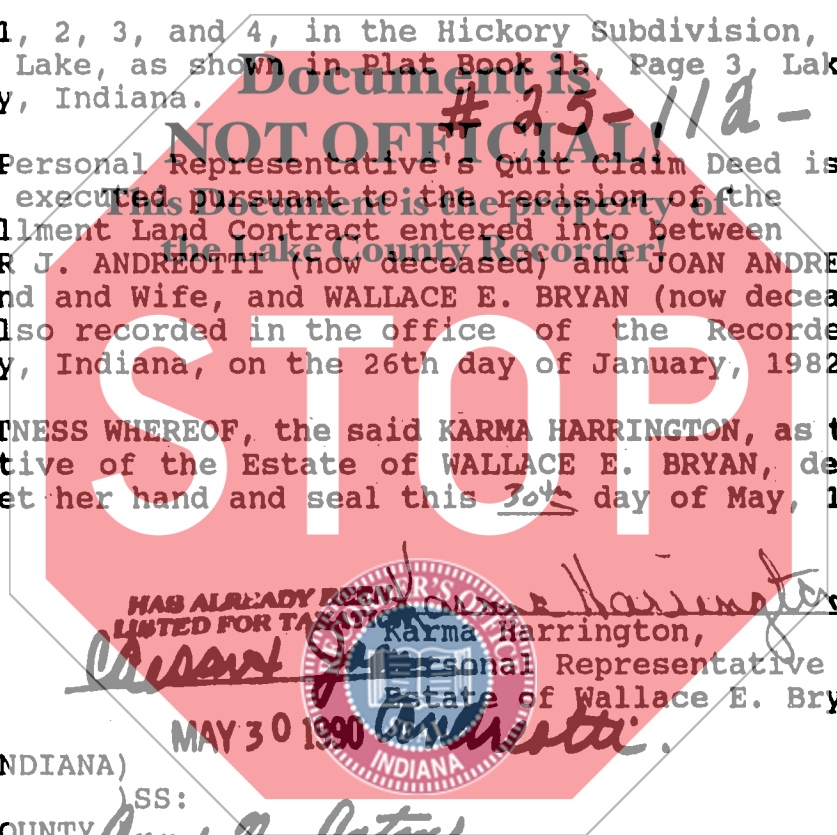
PERSONAL REPRESENTATIVE'S QUIT CLAIM DEED

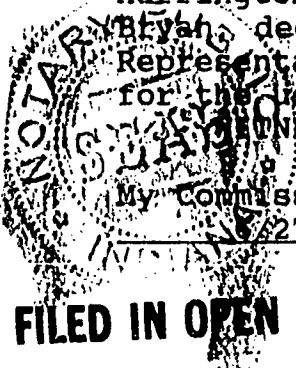
