This indenture witnesseth that Loretta Jorgensen, a widow and not remarried

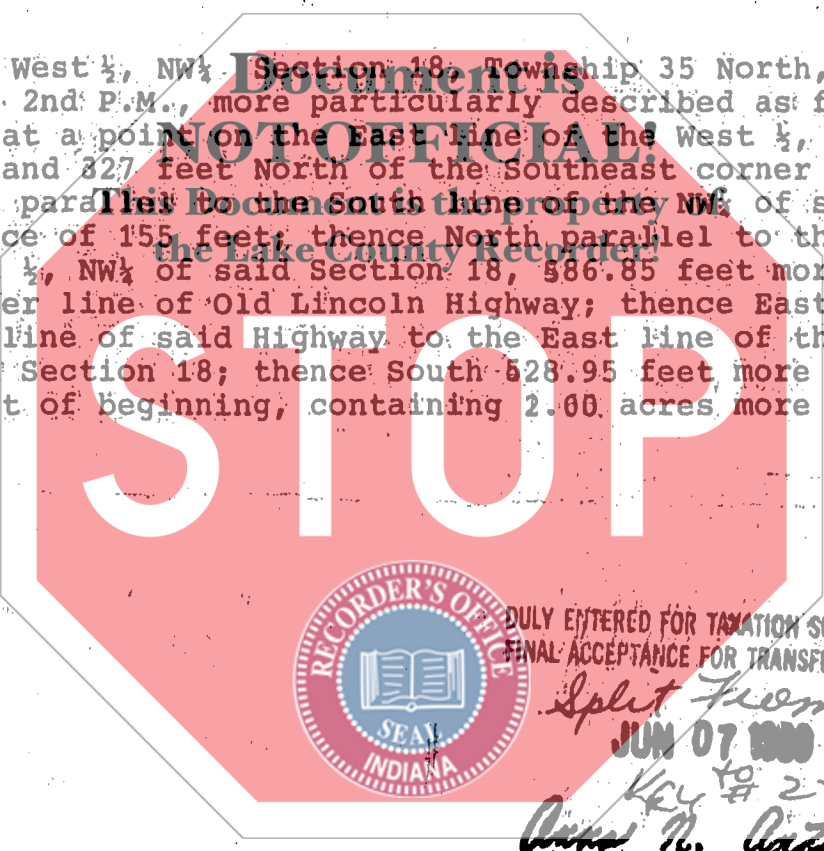
