AGREEMENT

This indenture made the 6 day of 1990 between Northen Indiana Public Service Company, (N/I.P.S.C.O.) an Indiana Corporation hereinafter called "Releasor" and Bank One Merrillville, N.A., as Trustee under trust dated August 1, 1988 numbered 96373054, and Bank One Merrillville, N.A. as Trustee under trust dated January 5, 1989 numbered 963850-54 and the First National Realty and Development Company, an Illinois Corporation hereinafter collectively called "Releasees";
