And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds that:

This Document is the property of

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.

2. That Ann Radecki a/k/a Ann M. Radecki, died testate, a resident of the County of Lake, State of Indiana, on the 30th day of January, 1986, and her Last Will and Testament was duly admitted to probate before this Court on the 7th day of March, 1986, and this Court appointed said Robert Radecki as executor of the Last Will and Testament of the decedent, and said executor was issued Letters of Testamentary on the 7th day of March 1986, to him, and since that date he has continued to serve in such capacity.

3. That the matters and things stated in said account and petition are true, and that said executor has accounted for all the assets in said estate coming into his hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor her executor were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. 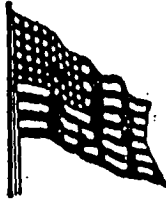
