That the Estate of JACK BELOSHAPKA is the owner in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows:

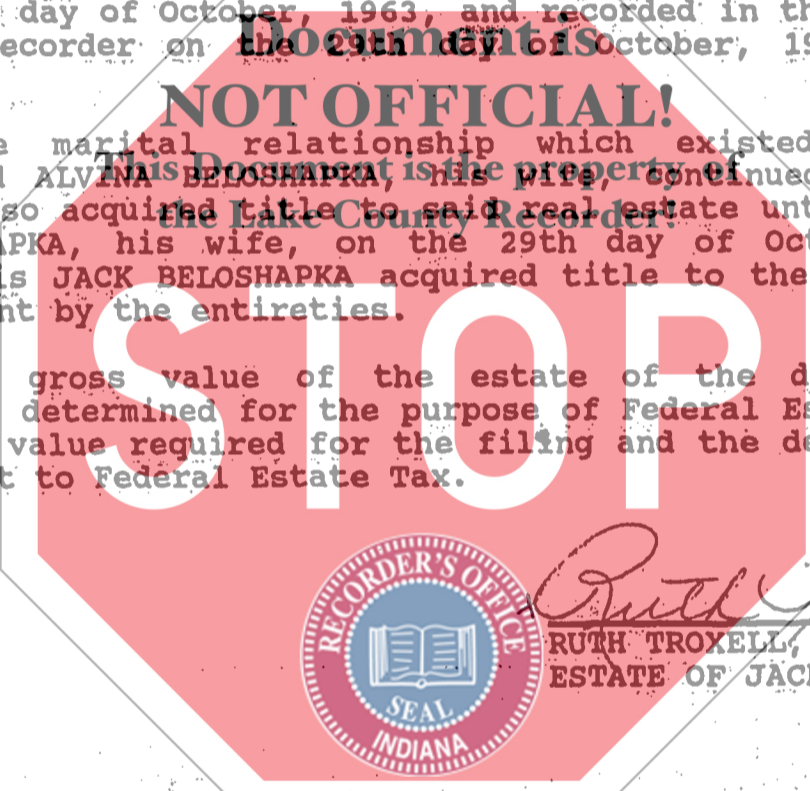

That the JACK BELOSHAPKA and the decedent, ALVINA BELOSHAPKA, were legally married. That the decedent, ALVINA BELOSHAPKA, and JACK BELOSHAPKA were husband and wife at the time they acquired title, as tenants by the entireties, to said real estate, by deed of conveyance dated the 25th day of October, 1963, and recorded in the Office of The Lake County Recorder on the 29th day of October, 1963 as document number 521734.

That the marital relationship which existed between JACK BELOSHAPKA and ALVINA BELOSHAPKA, his wife, continued unbroken from the time they so acquired title to said real estate until the death of ALVINA BELOSHAPKA, his wife, on the 29th day of October, 1976, at which time this JACK BELOSHAPKA acquired title to the real estate as surviving tenant by the entireties.

That the gross value of the estate of the decedent, ALVINA BELOSHAPKA, as determined for the purpose of Federal Estate Taxes, was less than the value required for the filing and the decedent's estate was not subject to Federal Estate Tax.
