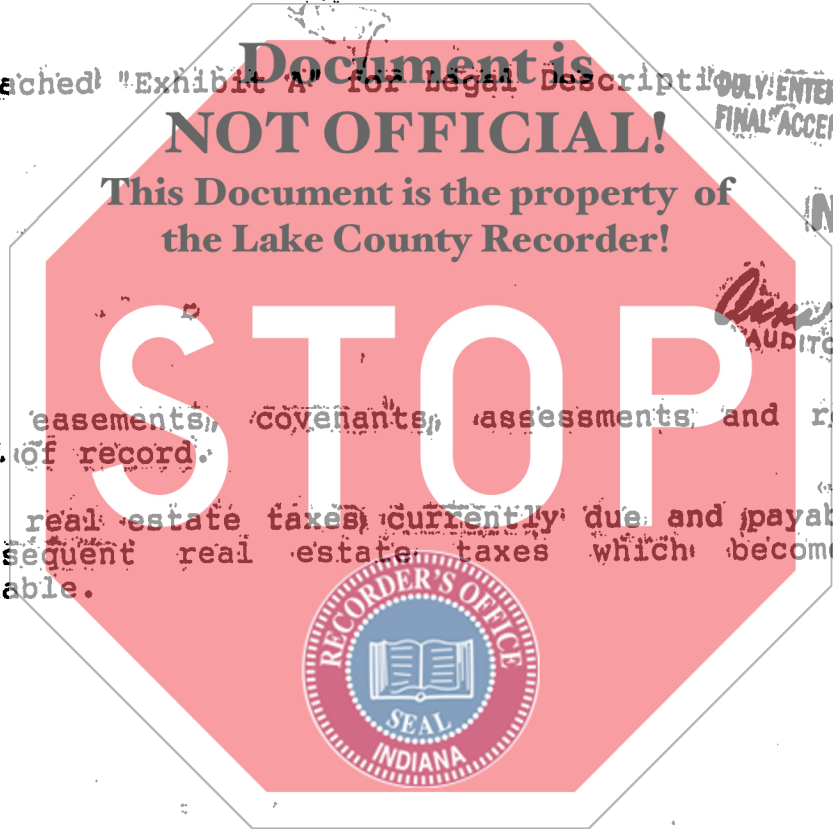

PARCEL I: 26-4-114

Part of the West $1/2$ of Section 3, Township 35 North, Range 9 West of the 2nd Principal Meridian, more particularly described as commencing at the intersection of the West line of said Section 3, and the Northerly property line of the Penn Central Railroad Company, as described in the Deed from Solomon H. Goldberg and wife, to the Joliet and Northern Indiana Railroad Company, recorded December 18, 1926 in Deed Record 388 page 474; thence Northeasterly along said Northerly property line a distance of 2213.29 feet; thence Southeasterly at right angles to the last described line a distance of 75 feet; thence Southwesterly on a line 75 feet Southeasterly of and parallel to the said Northerly property line a distance of 2239.68 feet; thence North on said West line of said Section 3; thence North on said West line a distance of 79.51 feet to the place of beginning, all in the Town of Griffith, Lake County, Indiana.
