1. Due notice of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate and the same are now properly before the Court for final action thereon.

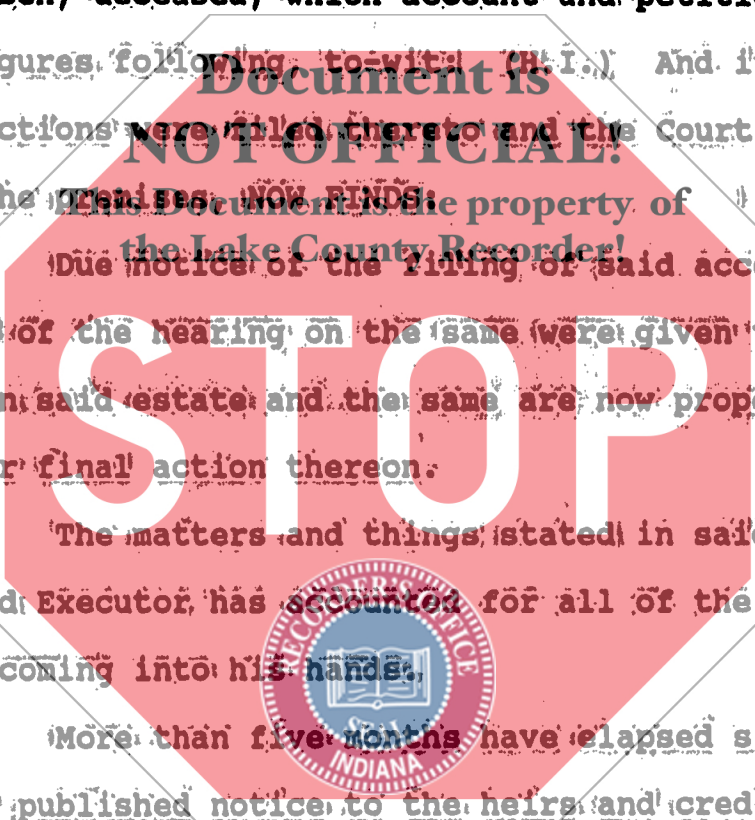
2. The matters and things stated in said account are true and said Executor has accounted for all of the assets in this estate coming into his hands.

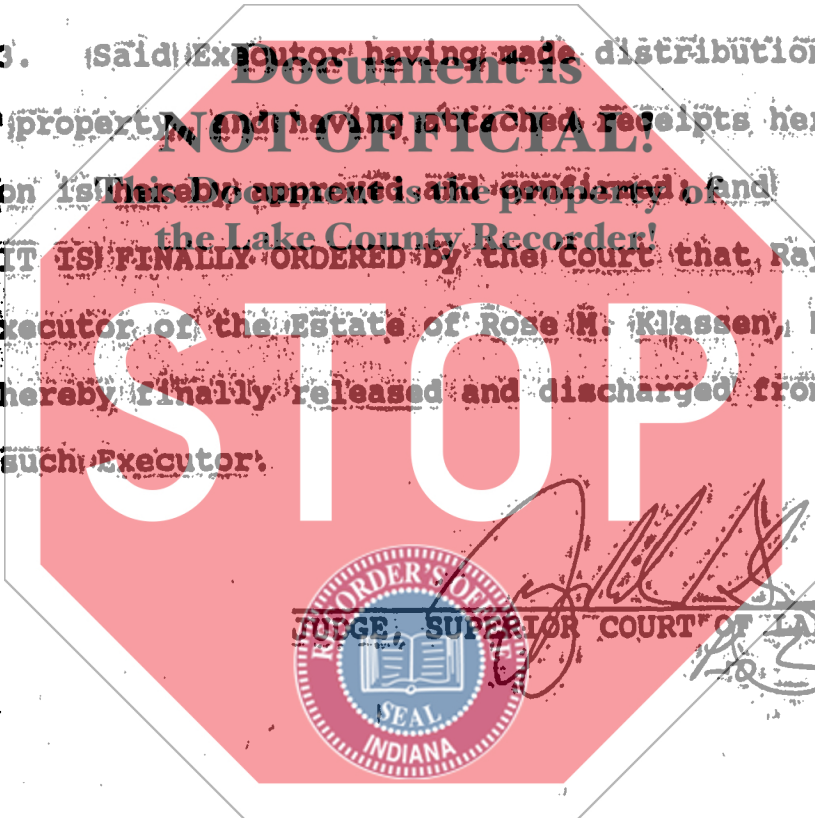
(b) The decedent's interest in the following described real estate which was undisposed of by sale or otherwise during the period of this administration is hereby vested in Mary Kathryn Klassen:

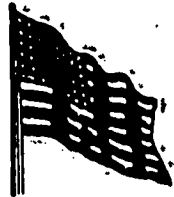
Said Executor is hereby directed to procure and to record in the Office of the Lake County Recorder a certified copy of this Final Decree.
