ORDER

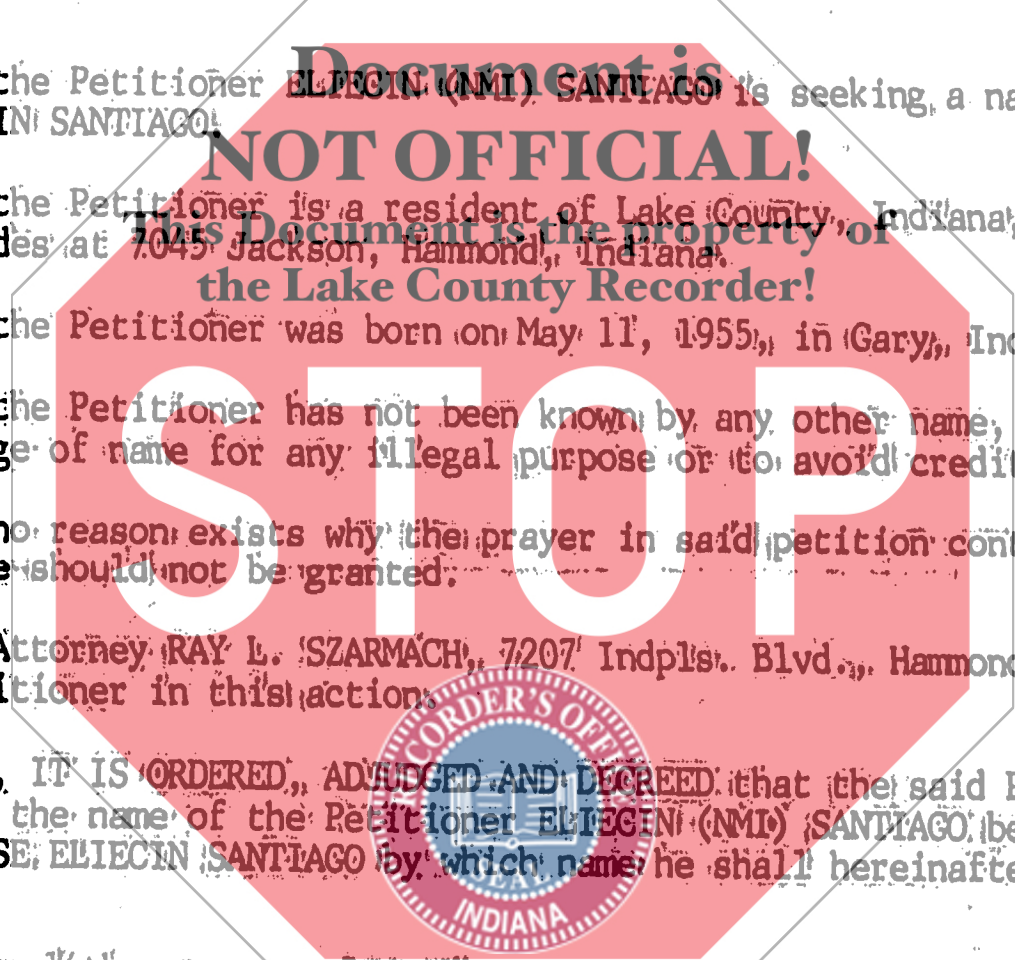

Of: ELIECIN (NMI) SANTIAGO

To: JESSE ELIECIN SANTIAGO

The final decree of a legal name change does not automatically amend an original birth record. When desired, an amendment to an original birth certificate must be specifically requested and some states require that the name change order include the amendment of the birth record as part of the decree. The cost and procedure for this amendment is determined by the state health department of the state of birth. (IC 16-1-15-5)
