she and I are competent.

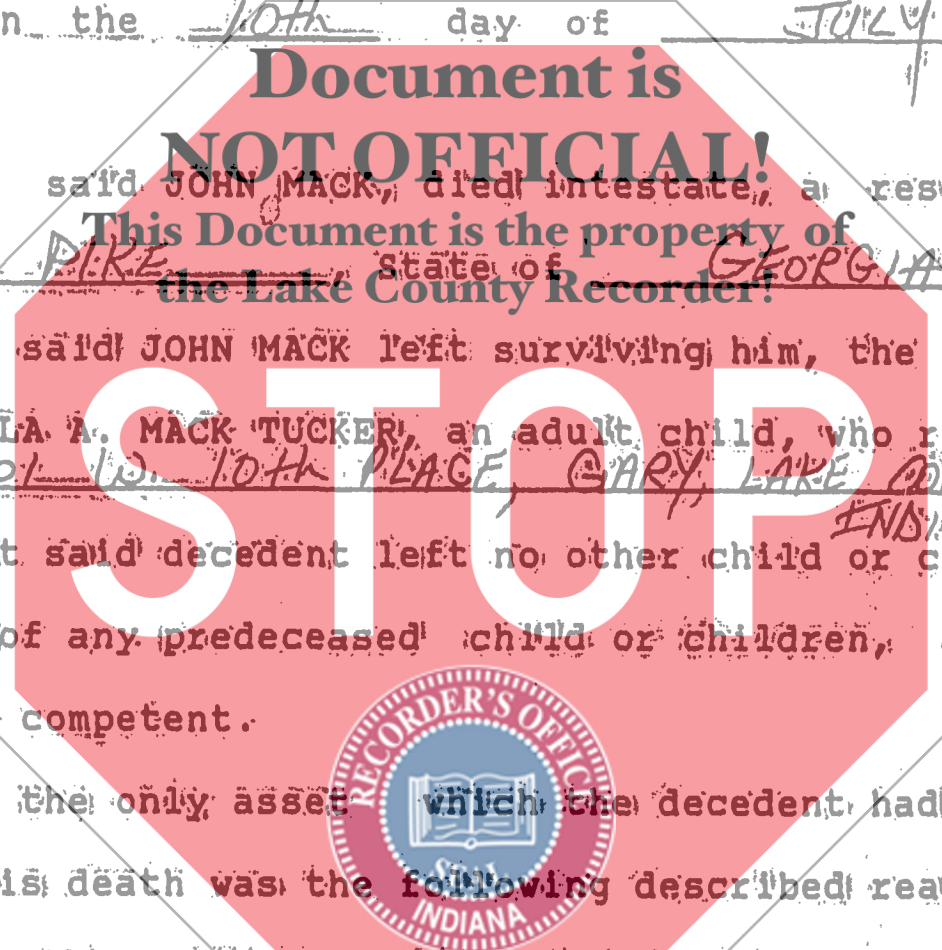
