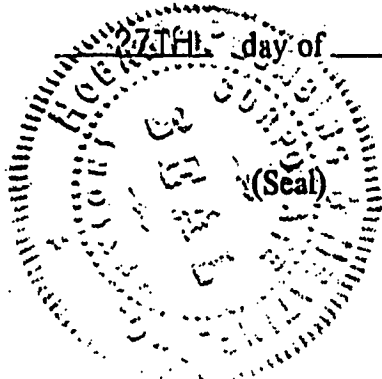
NOW, THEREFORE, in consideration of the issuance of such license, if said Principal shall well and truly comply with such

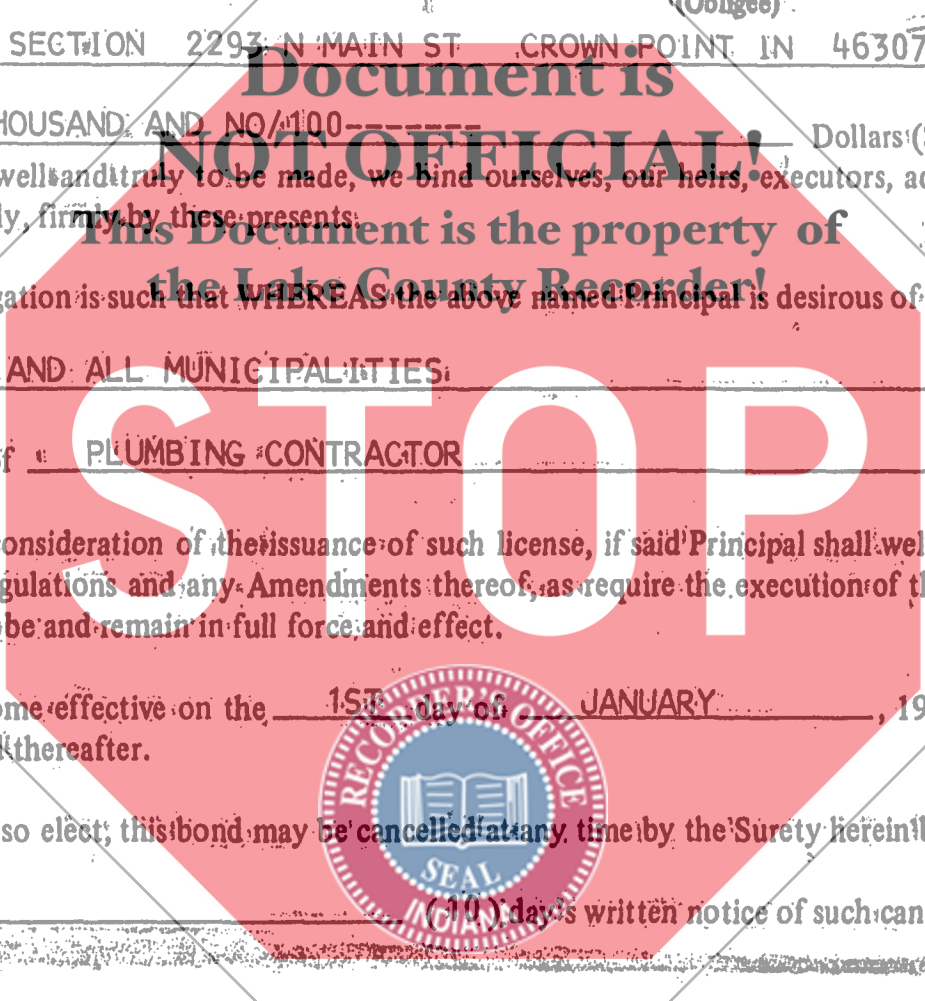


