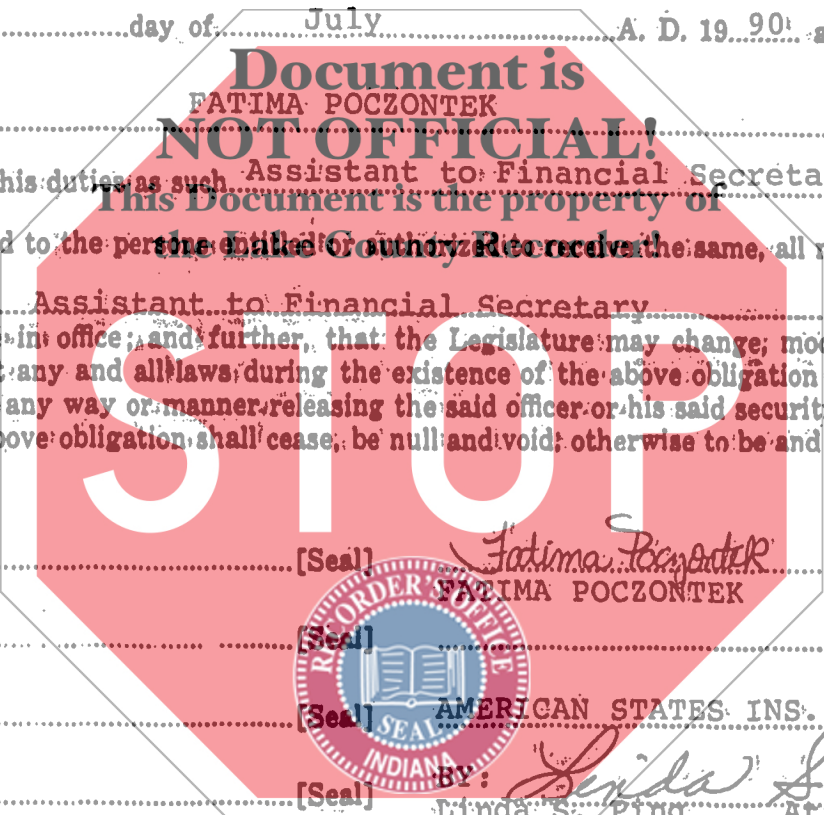
KNOW ALL MEN BY THESE PRESENTS, That we, FATIMA POCZONTEK, as Principal

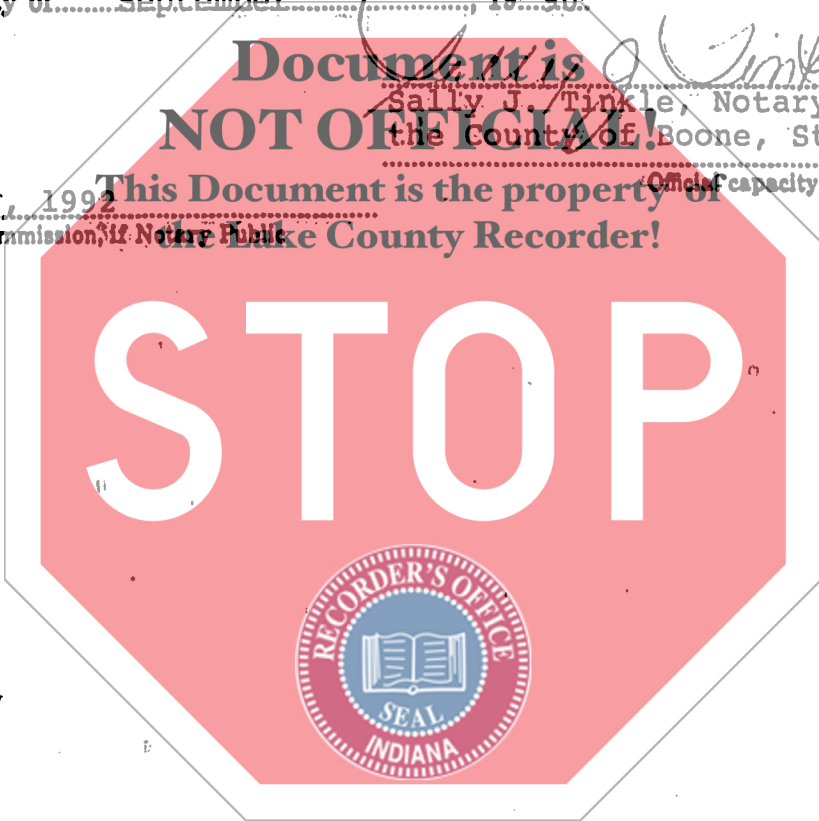
