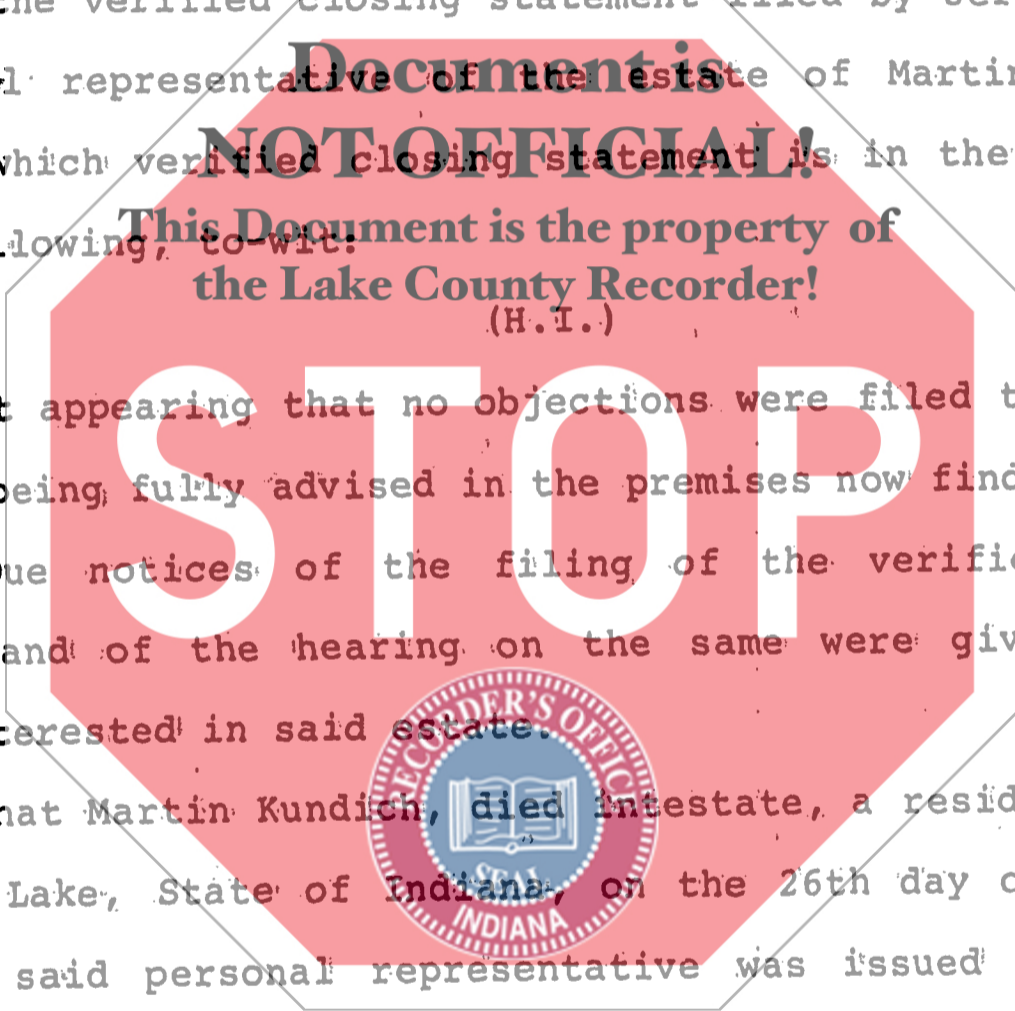

NUNC PRO TUNC ORDER APPROVING VERIFIED CLOSING STATEMENT

1. Due notices of the filing of the verified closing statement and of the hearing on the same were given to all persons interested in said estate.

2. That Martin Kundich, died intestate, a resident of the County of Lake, State of Indiana, on the 26th day of October, 1982, and said personal representative was issued Letters of Administration on the 19th day of January, 1983.

3. That the matters and things stated in said verified closing statement are true, and that said personal representative has accounted for all the assets in said estate coming into his hands.

4. More than five (5) months have elapsed since the date of first published notice to legatees, devisees and creditors of

said decedent; all claims filed against said estate have been paid and discharged; neither said decedent nor his personal representative were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. That the decedent died leaving the following heirs at law pursuant to the provisions of Indiana Code, I.C. 29-1-2-1,

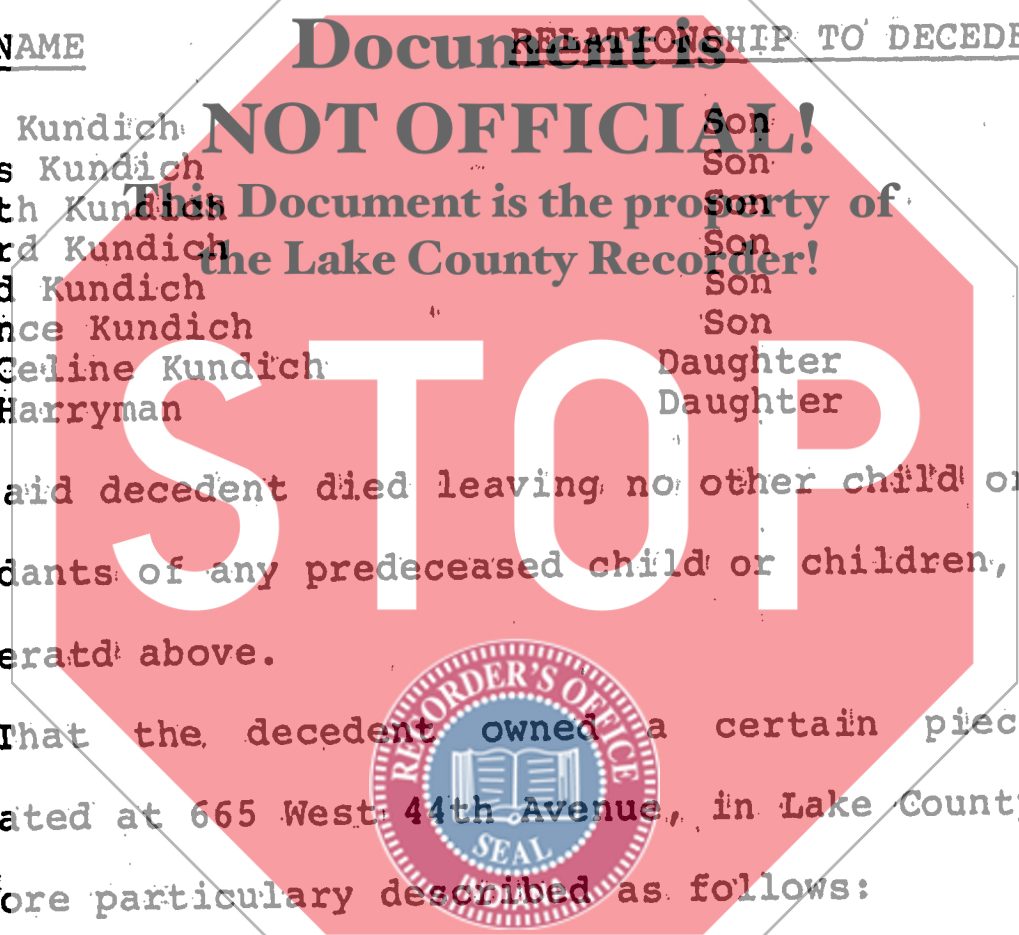

1. Said verified closing statement of said personal representative is hereby in all things approved, settled and confirmed.


2. That pursuant to the laws of intestacy, the following described real estate, to-wit:

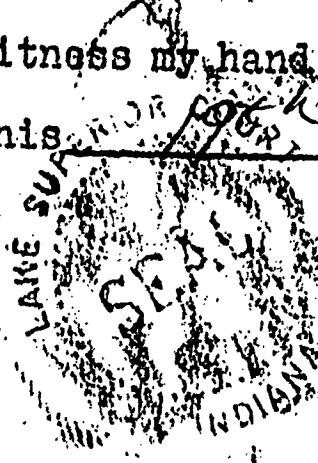
