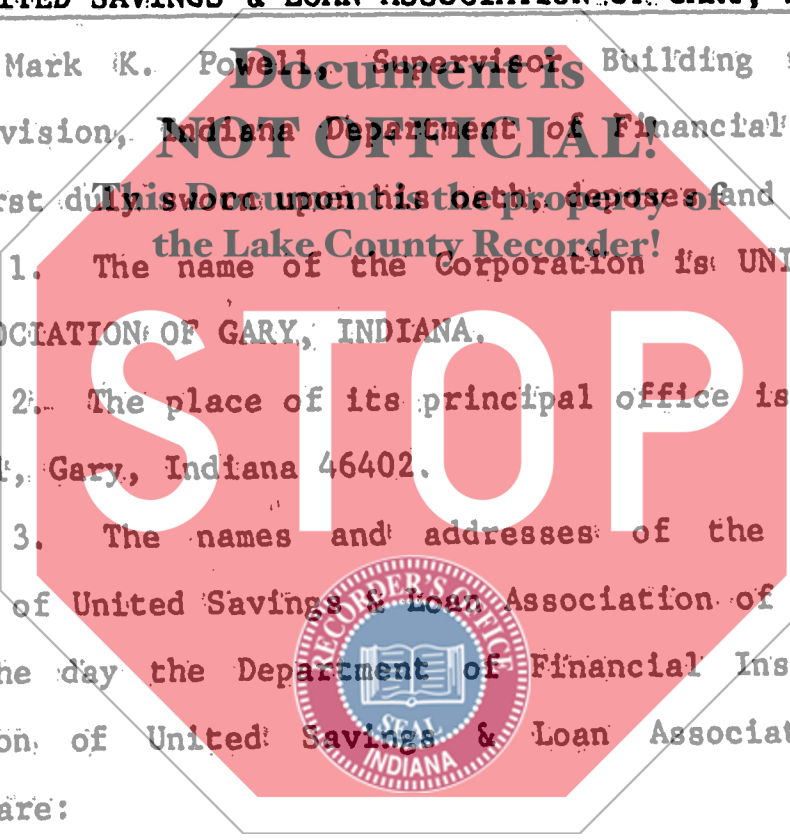



On February 11, 1988, the Directors of the Indiana Department of Financial Institutions examined the financial position of United Savings & Loan Association of Gary, Indiana, and determined that United Savings & Loan Association of Gary, Indiana, should be closed for purposes of Liquidation effective February 12, 1988.

5. On March 10, 1988, the Jasper Circuit Court confirmed the appointment of the Indiana Department of Financial Institutions as the receiver of United Savings & Loan Association of Gary, Indiana.

6. Attached hereto as Exhibit A is the Pay Out List For United Savings & Loan Association. That list shows all but two of the claims paid. The other two claims paid are \$197.85 paid to the Indiana Department of Financial Institutions and \$30.00 paid to the Indiana Secretary of State.

7. Attached as Exhibit B, is a list of abandoned Accounts To Be Turned Over To The Attorney General. The funds that remain as a result of the checks being returned or not cashed have been delivered to the Unclaimed Property Division of the Office of the Attorney General of Indiana.

I affirm under the penalties of perjury that the above representations are true.


